**Bill Summary**

The bill requires health benefit plans, except for supplemental policies, to provide coverage for severe protein allergic conditions including immunoglobulin E and nonimmunoglobulin E-mediated allergies to multiple food proteins; severe food protein induced enterocolitis syndrome; eosinophilic disorders as evidenced by the results of a biopsy; and impaired absorption of nutrients caused by disorders

1     *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 10-16-104, **amend**

3           (1) (c) (III) (A) and (1) (c) (III) (C) as follows:

3 inherited enzymatic disorders caused by single gene defects involved in  
4 the metabolism of amino, organic, and fatty acids and for SEVERE  
5 ALLERGIC CONDITIONS, IF DIAGNOSED BY A BOARD-CERTIFIED ALLERGIST  
6 OR BOARD-CERTIFIED GASTROENTEROLOGIST, FOR which medically  
7 standard methods of diagnosis, treatment, and monitoring exist. Such  
8 formulas are specifically processed or formulated to be deficient in one  
9 or more nutrients. and THE FORMULAS FOR SEVERE FOOD ALLERGIES  
10 CONTAIN ONLY SINGULAR FORM ELEMENTAL AMINO ACIDS. THE FORMULAS  
11 are to be consumed or administered enterally either via tube or oral route  
12 under the direction of a physician who is a participating provider. This  
13 sub subparagraph (C) shall not be construed to apply to cystic fibrosis  
14 patients or lactose- or soy-intolerant patients.

15 **SECTION 2. Act subject to petition - effective date.** This act  
16 takes effect January 1, 2018; except that, if a referendum petition is filed  
17 pursuant to section 1 (3) of article V of the state constitution against this  
18 act or an item, section, or part of this act within the ninety-day period  
19 after final adjournment of the general assembly, then the act, item,  
20 section, or part will not take effect unless approved by the people at the  
21 general election to be held in November 2016 and, in such case, will take  
22 effect on January 1, 2018, or on the date of the official declaration of the  
23 vote thereon by the governor, whichever is later.
