- 29 EXPERIENCE WORKING ON TRANSPORTATION PROJECTS;
- 30 (IV) THE MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES
- 31 SHALL APPOINT TWO MEMBERS, AT LEAST ONE OF WHOM MUST BE A
- 32 LICENSED ATTORNEY; AND
- 33 (V) THE MINORITY LEADER OF THE SENATE SHALL APPOINT TWO
- 34 MEMBERS, AT LEAST ONE OF WHOM MUST REPRESENT OR ADVOCATE FOR

- 1 TRANSIT PROVIDERS.".
