### **Bill Summary**

The bill creates the "Pet Store Consumer Protection Act", which prohibits a pet store that was not licensed by the commissioner of agriculture prior to the effective date of the bill from selling or offering to sell dogs or cats on or after the effective date of the bill.

The bill also requires each pet store licensed to sell or offer to sell dogs or cats that continues to sell or offer to sell dogs or cats to:

- Include on all advertisements, including website postings, the purchase price of the dog or cat and any applicable federal or state license numbers for the breeder of the dog or cat;

- Make certain written disclosures to a prospective consumer prior to selling a dog or cat.

7	(9.3) (a) "Offer for sale" means to advertise a potential

9	(b) "Offer for sale" includes:
10	(I) THE DISPLAY OF A LIVE DOG OR CAT FOR SALE; AND
11	(II) A VERBAL OR WRITTEN OFFER TO SELL A DOG OR CAT.
12	(11.3) "PET STORE" MEANS A RETAIL ESTABLISHMENT WHERE PET
13	ANIMALS ARE SOLD OR OFFERED FOR SALE TO THE GENERAL PUBLIC. "PET
14	STORE" DOES NOT INCLUDE AN ANIMAL SHELTER, PET ANIMAL RESCUE, CAT
15	BREEDER, OR DOG BREEDER.
16	(11.7) "SALE" OR "SELL" MEANS THE EXCHANGE OF A PET ANIMAL
17	FOR ANYTHING OF VALUE, INCLUDING PROPERTY OR MONEY. "SALE" OR

14	general election to be held in November 2022 and, in such case, will take
15	effect on the date of the official declaration of the vote thereon by the
16	governor.

18	effective date of this act.
