HB21-1271 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:
Amend printed bill, page 5, line 17, strike "housing," and substitute "housing and more liveable and vibrant communities,".
Amend printed bill, page 8, strike line 25 and substitute "THAT ARE DRIVEN BY COMMUNITY BENEFITS AND THAT FOCUS ON CRITICAL HOUSING NEEDS AS IDENTIFIED BY THE LOCAL GOVERNMENT.".
Page 9, lines 10 and 11, strike "AS, WITHOUT LIMITATION:" and substitute "INCLUDING BUT NOT LIMITED TO:".
Page 9, line 12, after "VACANT" insert "PUBLICLY OWNED".
Page 9, line 15, strike "PERMITTING FEES" and substitute "FEES, INCLUDING BUT NOT LIMITED TO BUILDING PERMIT FEES, PLANNING WAIVERS, AND WATER AND SEWER TAP FEES,".
Page 9, strike lines 26 and 27 and substitute:
"(E) THE ESTABLISHMENT OF A DENSITY BONUS PROGRAM TO INCREASE THE CONSTRUCTION OF UNITS THAT MEET CRITICAL HOUSING NEEDS IN THE LOCAL COMMUNITY;".
