#### **Summary of Legislation**

**Recommended by the Joint Budget Committee**, this bill creates the Community Museums Cash Fund to receive fees, membership dues, and other revenue earned at History Colorado's community museums. Money in this fund is subject to annual appropriation for the direct and indirect costs of carrying out activities of community museums. These revenues are separated from earned revenue to History Colorado, which is deposited in the Enterprise Services Cash Fund.

### **Background**

History Colorado operates eight community museums located throughout the state. The FY 2017-18 Long Bill provides total appropriations of \$2,948,601 and 20.5 FTE for the community museums, including \$1,461,401 General Fund, \$640,200 from the State Historical Fund (gaming Revenue), and \$847,000 from the Enterprise Services Cash Fund (earned revenue).

### **State Revenue**

The bill shifts revenue to different cash funds associated with History Colorado, but results in no net change in state revenue. This bill will decrease revenue by \$847,000 in the Enterprise Services Cash Fund in the Department of Higher Education (DHE), and increase revenue by an equal amount in the newly created Community Museum Cash Funds. Fees, membership dues, and other revenue earned at History Colorado's community museums will be deposited in this fund.

### **State Expenditures**

The bill shifts spending between cash funds in DHE for History Colorado's community museums, but will result in no net change in costs. The bill specifies that if available revenue in the Community Museums Cash Fund is less than the appropriated amount, an amount equal to the unused balance is appropriated from the Enterprise Services Cash Fund.

#### **Effective Date**

The bill takes effect upon signature of the Governor, or upon becoming law without his signature.

## **State Appropriations**

For FY 2017-18, the bill includes the following appropriations:

- a decrease of \$847,000 to the Department of Higher Education from the Enterprise Services Cash Fund:
- an increase of \$847,000 to the Department of Higher Education for community museums from the Community Museums Cash Fund;
- a conditional appropriation of up to \$847,000 to the Department of Higher Education from the Enterprise Services Cash Fund if revenue in the Community Museums Cash Fund is not sufficient to fully fund the appropriation from the Community Services Cash Fund.
