HOUSE RESOLUTION 25-1003 101 CONCERNING THE RECOGNITION OF THE IMPORTANCE OF A DIVERSE 102 LEGAL COMMUNITY IN COLORADO AND HONORING THE 103 CONTRIBUTIONS OF THE COLORADO WOMEN'S BAR 104 ASSOCIATION. 1 WHEREAS, The legal profession upholds the nation's values, 2 including the rule of law, equal justice, judicial independence, 3 accountability, excellence, advancing justice, and upholding the highest 4 standards of the legal profession; and 5 WHEREAS, Historically, women faced significant barriers to entering the legal field, and, even after admission, they have continued to 6 encounter challenges; and 7 8 WHEREAS, In 1894, Jeannette Dunham Bennett and Ann Hunt 9 became the first women to earn law degrees in Colorado, marking the 10 beginning of women's formal entry into the state's legal profession; and 11 WHEREAS, In 1897, the Colorado General Assembly enacted a 12 statute ensuring that no person could be denied a license to practice law 13 on account of race or sex, reflecting the state's early commitment to

1	inclusivity in the legal profession; and
2 3 4	WHEREAS, In 1903, Ida L. Gregory became Colorado's first female judge, setting a precedent for women's leadership in the judiciary; and
5 6 7	WHEREAS, In 1917, Clara Ruth Mozzor was appointed as Assistant Attorney General of Colorado, becoming the first woman to serve in such a role in any American state; and
8 9 10	WHEREAS, Gale Norton served as Colorado's Attorney General from 1991 to 1999, becoming the first woman to hold this position in the state; and
11 12 13	WHEREAS, In 1994, Claudia J. Jordan became the first African American female judge in Colorado, further diversifying the state's judiciary; and
14 15 16	WHEREAS, In 1997, Theresa M. Cisneros became the first Hispanic American female judge in Colorado's Fourth Judicial District; and
17 18	WHEREAS, In 2016, Chelsea Malone, who is of Korean descent, became the first Asian American female state judge in Colorado; and
19 20 21	WHEREAS, In 2024, Monica M. Márquez became the first Latina and first openly gay person to serve as Chief Justice of the Colorado Supreme Court; and
22 23	WHEREAS, As of 2024, women comprised 41% of attorneys in Colorado, reflecting significant progress over the past decades; and
24 25 26 27	WHEREAS, The Colorado Women's Bar Association (CWBA) has been instrumental in promoting the advancement of women in the legal profession and advocating for a more diverse and representative legal system; and
28 29 30 31 32	WHEREAS, The CWBA's Judicial Committee assists qualified women statewide in applying for judicial positions and openings on judicial nominating commissions, encouraging the advancement of women in the judiciary and fighting bias and discrimination against women in the courtroom; and

1 2	WHEREAS, The CWBA works to increase access to justice and representation in all areas of the legal system, including the judiciary; and
3 4 5	WHEREAS, A diverse legal community enhances the quality of justice and ensures that the legal system serves all citizens effectively and
6 7 8	WHEREAS, March is nationally recognized as Women's History Month, a time to honor women's contributions in American history; now therefore,
9 10	Be It Resolved by the House of Representatives of the Seventy-fifth General Assembly of the State of Colorado:
11 12 13 14 15	(1) That we recognize the vital importance of diversity within Colorado's legal community and commend the Colorado Women's Bar Association for its unwavering commitment to supporting the advancement of women and strengthening the legal profession in our state; and
16 17 18 19	(2) That we encourage continued efforts to foster a legal environment that values merit, integrity, and the diverse perspectives of all its members, ensuring that the legal system remains fair and just for every Coloradan.
