## **Current Appropriations Clause in Bill**

The bill requires but does not contain an appropriation clause.

## **Description of Amendments in This Packet**

#### J.001

Staff amendment **J.001** (attached) appropriates a total of \$140,443 General Fund to the Judicial Department for FY 2025-26. The appropriation reflects 1.1 FTE.

## L.004

Sponsor amendment **L.004** (attached) allows the custodian of a final report to deny inspection of the report while there is an ongoing criminal investigation or criminal case against a crime laboratory employee. Provides that the final report must be open for public inspection upon adjudication of the wrongful action. Legislative Council Staff and JBC Staff agree that this amendment does not change the fiscal impact.

#### L.005

Sponsor amendment **L.005** (attached) adds reporting requirements as part of the SMART Act presentations about cases related to wrongful action by a crime lab for the Judicial Department (State Courts), Office of State Public Defender, Office of Alternate Defense Counsel, and the Department of Law. Requires DAs to provide the State Court Administrator's Office information necessary for the Judicial Department to make their report. Legislative Council Staff and JBC Staff agree that this amendment imposes a reporting requirement for data that can be collected through agency processes and therefore does not change the fiscal impact.

The Committee should adopt J.001 and may adopt either or both L.004 and L.005.

## **Points to Consider**

#### **General Fund Impact**

The Joint Budget Committee has proposed a budget package for FY 2025-26 based on the March 2025 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$18.2 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders.

This bill requires a General Fund appropriation of \$140,443 for FY 2025-26, reducing the \$18.2 million set aside by the same amount.
