A BILL FOR AN ACT
CONCERNING THE CREATION OF A POSITION IN THE OFFICE OF THE
GOVERNOR THAT COORDINATES THE PERMITTING OF WATER
PROJECTS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Section 1 of the bill creates a position in the office of the governor, designated as the director of water project permitting, to coordinate the permitting of:

! Raw water diversion, storage, or delivery projects, including associated hydroelectric facilities and both

! Water projects that are either assessed a water quality certification fee or are eligible for financing from the Colorado water conservation board construction fund.

Sections 2 and 3 direct the annual transfer of \$___ each from the water quality certification sector fund and the Colorado water conservation board construction fund to the newly created water permitting coordination fund.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, add 24-20-114 as 3 follows: 4 24-20-114. Director of water project permitting - water 5 **permitting coordination fund.** (1)(a) THERE IS HEREBY CREATED IN THE 6 OFFICE OF THE GOVERNOR THE POSITION OF DIRECTOR OF WATER PROJECT 7 PERMITTING. 8 (b) THE ORGANIZATIONAL LOCATION OF THE DIRECTOR IS AT THE 9 DISCRETION OF THE GOVERNOR. 10 (2) (a) THE WATER PERMITTING COORDINATION FUND, REFERRED 11 TO IN THIS SECTION AS THE FUND, IS HEREBY CREATED IN THE STATE 12 TREASURY. THE FUND CONSISTS OF EQUAL AMOUNTS OF MONEY 13 ANNUALLY TRANSFERRED TO THE FUND FROM THE WATER QUALITY 14 CERTIFICATION SECTOR FUND IN ACCORDANCE WITH SECTION 25-8-502 15 (1.2) (d), C.R.S., AND FROM THE COLORADO WATER CONSERVATION 16 BOARD CONSTRUCTION FUND IN ACCORDANCE WITH SECTION 37-60-121 17 (11), C.R.S., AND ANY OTHER MONEY THAT THE GENERAL ASSEMBLY MAY 18 APPROPRIATE OR TRANSFER TO THE FUND. THE SUM OF THE ANNUAL 19 TRANSFERS SPECIFIED IN THIS PARAGRAPH (a) MUST EQUAL THE INDIRECT 20 AND DIRECT COSTS OF THE DIRECTOR TO IMPLEMENT THIS SECTION.

19	state constitution against this act or an item, section, or part of this act
20	within such period, then the act, item, section, or part will not take effect
21	unless approved by the people at the general election to be held in
22	November 2016 and, in such case, will take effect on the date of the
23	official declaration of the vote thereon by the governor.
