A BILL FOR AN ACT

101 CONCERNING ACCESS TO STATE PARKS BY PURPLE HEART RECIPIENTS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill allows Colorado residents who display a purple heart special license plate free entrance to any state park or recreation area, not including campgrounds, on any day of the year that such park or area is open.

The bill also allows a Colorado resident to acquire a free transferable annual state parks pass by presenting the same documents required for a purple heart special license plate at a regional office or the central office of the division of parks and wildlife, or at any other SENATE

Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 33-12-106, amend 3 (1)(a); and **add** (1)(c) as follows: 4 33-12-106. Park entrance privileges - identified veterans -5 wounded warriors - search and rescue organizations conducting 6 training activities - legislative declaration - rules. (1) (a) Any resident 7 who displays on the resident's vehicle a Colorado disabled veteran's 8 license plate pursuant to section 42-3-304 (3)(a) OR A PURPLE HEART 9 SPECIAL LICENSE PLATE PURSUANT TO SECTION 42-3-213 (2) must be 10 allowed free entrance to any state park or recreation area, not to include 11 campgrounds, on any day of the year such park or area is open. For the 12 purpose of this section, display of such license plates entitles the disabled 13 veteran OR PURPLE HEART RECIPIENT and passengers in such DISABLED 14 veteran's OR PURPLE HEART RECIPIENT'S vehicle to enter such park or 15 recreation area free of charge. 16 (c) ANY RESIDENT WHO PRESENTS THE DOCUMENTS NECESSARY TO 17 SATISFY THE REQUIREMENTS OF SECTION 42-3-213 (2) AT A REGIONAL 18 OFFICE OR THE CENTRAL OFFICE OF THE DIVISION, OR AT SUCH OTHER 19 LOCATIONS AS MAY BE DETERMINED BY THE DIVISION, MAY OBTAIN A 20 TRANSFERABLE ANNUAL PARKS PASS FREE OF CHARGE FROM THE DIVISION. 21 **SECTION 2.** Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the 22 23 ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V 24
