The Senate Appropriations Committee Report (05/26/21) added a provision that adjusts FY 2021-22 appropriations (described in detail below), shifting \$1,135,728 from the *Marijuana Cash Fund* (MCF) to the *Marijuana Tax Cash Fund* (MTCF), and eliminating a corresponding appropriation of \$1,135,728 reappropriated funds.

Current Appropriations Clause in Bill

The bill includes a provision that adjusts appropriations in the FY 2021-22 Long Bill, reducing appropriations from the MCF by \$1,135,728 and increasing appropriations from the MTCF by the same amount. The affected line item appropriation supports the Department of Public Health and Environment's inspection and certification of laboratories that conduct marijuana-related testing. This amendment also eliminates a duplicate appropriation in the Department of Revenue.

Points to Consider

General Fund Impact

The Joint Budget Committee (JBC) has proposed a budget package for FY 2021-22 based on the March 2021 Legislative Council Staff revenue forecast. The JBC has included as part of its FY 2021-22 budget package the \$4,300,000 General Fund revenue decrease that would result from the passage of this bill.

Marijuana Tax Cash Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2021-22 based on the March 2021 Legislative Council Staff revenue forecast. The budget package leaves approximately \$20.4 million available for appropriation or transfer from the Marijuana Tax Cash Fund for FY 2021-22, based on that revenue forecast. This bill includes an appropriation of \$1,135,728 from the Marijuana Tax Cash Fund for FY 2021-22, reducing the anticipated balance by the same amount.
