**A BILL FOR AN ACT**

101      **CONCERNING COMPREHENSIVE SOCIO-CULTURAL BLACK HISTORY**  
102              **EDUCATION IN PUBLIC SCHOOLS, AND, IN CONNECTION**  
103              **THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill requires the state board of education to adopt standards related to Black historical and cultural studies (standards) on or before July 1, 2026. For school years beginning on or after July 1, 2028, local education providers shall incorporate the standards into courses for public elementary and secondary school students in the state.

The bill creates the Black historical and cultural studies advisory committee (committee) in the department of education (department) to recommend standards and related materials and to contribute technical assistance at the request of local education providers implementing the standards. The committee's recommendations must advance developmentally appropriate but comprehensive instruction that features factual accounts of the struggles and contributions of Black Americans in all fields of endeavor.

Using the committee's recommendations, the department shall create and maintain a resource bank of research-based, scholarly articles and promising program materials and curricula pertaining to Black historical and cultural studies.

6 OTHERWISE REQUIRES:

7 (a) "BLACK HISTORICAL AND CULTURAL STUDIES" MEANS AN  
8 INTERDISCIPLINARY PROGRAM OF ELEMENTARY THROUGH SECONDARY  
9 ACADEMIC STUDY THAT:

10 (I) REPRESENTS BLACK HISTORICAL EXPERIENCES THROUGH  
11 TRUTHFUL, INCLUSIVE, COMPLEX NARRATIVES THAT CONNECT WITH  
12 CONTEMPORARY REALITIES; AND

13 (II) HIGHLIGHTS THE INNOVATIONS AND CULTURAL  
14 CONTRIBUTIONS OF BLACK PEOPLE IN COLORADO, AMERICA, AND THE  
15 WORLD.

16 (b) "LOCAL EDUCATION PROVIDER" MEANS:

17 (I) A SCHOOL DISTRICT;

18 (II) A CHARTER SCHOOL AUTHORIZED BY A SCHOOL DISTRICT

14 DEPARTMENT TO BE IMPLEMENTED IN CONJUNCTION WITH THE REGULAR  
15 SIX-YEAR REVIEW OF THE STATE'S EDUCATION STANDARDS AND PROGRAMS

19           (3)(a) THE BLACK HISTORICAL AND CULTURAL STUDIES ADVISORY

21 DESIGNATED APPOINTING OFFICIALS AS FOLLOWS:

22           (I) THE GOVERNOR SHALL APPOINT, THROUGH THE OFFICE OF  
23 BOARDS AND COMMISSIONS, THE FOLLOWING MEMBERS OF THE  
24 COMMITTEE:

25           (A) ONE MEMBER WHO IS AN ACADEMIC EXPERT IN BLACK

27           (B) ONE MEMBER WHO IS A HISTORIAN WITH EXPERTISE IN THE

- 6 (D) ONE MEMBER WHO IS A TEACHER IN A SCHOOL DISTRICT THAT
- 7 IS NOT A RURAL SCHOOL DISTRICT OR A SMALL RURAL SCHOOL DISTRICT,
- 8 AS DEFINED IN SECTION 22-7-1211, AND HOLDS AN INITIAL OR
- 9 PROFESSIONAL TEACHER'S LICENSE PURSUANT TO ARTICLE 60.5 OF THIS

- 11 (E) ONE MEMBER WHO IS A LIBRARIAN SPECIALIZING IN BLACK
- 12 ARTS AND CULTURE AND WHO IS A MEMBER OF A PROFESSIONAL

- 14 (F) TWO MEMBERS WHO ARE CURRICULUM SPECIALISTS, ONE OF
- 15 WHOM SPECIALIZES IN ELEMENTARY EDUCATION, ONE OF WHOM
- 16 SPECIALIZES IN SECONDARY EDUCATION, AND BOTH OF WHOM ARE
- 17 MEMBERS OF A PROFESSIONAL ASSOCIATION;
- 18 (G) ONE MEMBER WHO IS A PARENT OR LEGAL GUARDIAN OF A
- 19 STUDENT WHO ATTENDS A PUBLIC SCHOOL AND IS A MEMBER OF A PARENT
- 20 ORGANIZATION;
- 21 (H) TWO MEMBERS WHO EACH REPRESENT A NONPROFIT
- 22 ORGANIZATION SPECIALIZING IN CIVIL RIGHTS AND RACIAL JUSTICE WITH
- 23 AN EMPHASIS ON COMPREHENSIVE BLACK HISTORICAL AND CULTURAL
- 24 EDUCATION IN PUBLIC SCHOOLS;
- 25 (I) ONE MEMBER WHO REPRESENTS A NONPROFIT ORGANIZATION
- 26 SPECIALIZING IN BLACK ARTS AND CULTURE; AND
- 27 (J) TWO MEMBERS FROM THE BLACK COMMUNITY WHOSE

1 LEADERSHIP IN LITERARY, ARTISTIC, MILITARY, BUSINESS, SCIENCE,  
2 TECHNOLOGY, MEDIA, OR CIVIC LIFE CONTRIBUTES VALUABLE LIVED  
3 EXPERIENCE TO THE WORK OF THE COMMITTEE;

4 (II) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL  
5 APPOINT ONE MEMBER;

6 (III) THE PRESIDENT OF THE SENATE SHALL APPOINT ONE MEMBER;  
7 AND

8 (IV) THE COMMISSIONER SHALL APPOINT TWO MEMBERS FROM THE  
9 DEPARTMENT, WHO ARE NONVOTING MEMBERS.

10 (b) THE MEMBERSHIP OF THE COMMITTEE MUST REFLECT A DEEP  
11 COLLECTIVE UNDERSTANDING OF BLACK HISTORY AND CULTURE, WITH  
12 DEMONSTRATED EXPERTISE IN BLACK HISTORY, SOCIAL EQUITY, AND CIVIL  
13 RIGHTS. A MAJORITY OF THE COMMITTEE MEMBERS MUST HAVE EITHER  
14 CLASSROOM EXPERIENCE OR EXPERIENCE IN DEVELOPING EDUCATION  
15 CONTENT STANDARDS.

16 (c) THE APPOINTING OFFICIALS SHALL MAKE THE INITIAL  
17 APPOINTMENTS TO THE COMMITTEE NO LATER THAN AUGUST 15, 2025.

18 (d) THE TERM OF APPOINTMENT IS FOUR YEARS. THE APPOINTING  
19 OFFICIALS SHALL FILL ANY VACANCIES ON THE COMMITTEE FOR THE  
20 REMAINDER OF ANY UNEXPIRED TERM.

21 (4) MEMBERS OF THE COMMITTEE SERVE WITHOUT COMPENSATION  
22 AND WITHOUT REIMBURSEMENT FOR EXPENSES.

23 (5) (a) THE COMMITTEE SHALL ELECT A CHAIR FROM AMONG THE  
24 COMMITTEE'S MEMBERS TO SERVE FOR A TERM NOT TO EXCEED TWO  
25 YEARS, AS DETERMINED BY THE COMMITTEE.

26 (b) THE COMMITTEE SHALL MEET AT LEAST ONCE IN 2025, AND AT  
27 LEAST TWICE ANNUALLY EACH YEAR THEREAFTER. THE CHAIR MAY CALL

1 SUCH ADDITIONAL MEETINGS AS ARE NECESSARY FOR THE COMMITTEE TO  
2 COMPLETE ITS DUTIES.

3 (6) THE COMMITTEE SHALL:

4 (a) MAKE RECOMMENDATIONS TO THE STATE BOARD AND THE  
5 DEPARTMENT REGARDING STANDARDS THAT IDENTIFY THE KNOWLEDGE  
6 AND SKILLS THAT ELEMENTARY THROUGH SECONDARY EDUCATION  
7 STUDENTS SHOULD ACQUIRE RELATED TO BLACK HISTORICAL AND  
8 CULTURAL STUDIES PURSUANT TO SECTION 22-7-1005 (2.9) AND DEVELOP  
9 RECOMMENDATIONS FOR THE STATE BOARD TO IMPLEMENT DURING ITS  
10 SIX-YEAR REVIEW OF THE STATE'S EDUCATION STANDARDS;

11 (b) IDENTIFY AND RECOMMEND MATERIALS AND RESOURCES FOR  
12 INCLUSION IN THE RESOURCE BANK CREATED PURSUANT TO SUBSECTION  
13 (8) OF THIS SECTION; AND

14 (c) AT THE REQUEST OF A LOCAL EDUCATION PROVIDER,  
15 COLLABORATE WITH THE DEPARTMENT TO PROVIDE TECHNICAL  
16 ASSISTANCE TO THE LOCAL EDUCATION PROVIDER IN DESIGNING  
17 AGE-APPROPRIATE CURRICULA PERTAINING TO BLACK HISTORICAL AND  
18 CULTURAL STUDIES.

19 (7)(a) IN MAKING RECOMMENDATIONS PURSUANT TO SUBSECTION  
20 (6)(a) OF THIS SECTION, THE COMMITTEE SHALL COORDINATE WITH THE  
21 HISTORY, CULTURE, SOCIAL CONTRIBUTIONS, AND CIVIL GOVERNMENT IN  
22 EDUCATION COMMISSION ESTABLISHED PURSUANT TO SECTION 22-1-104.3  
23 AND MAY CONSIDER THE FINDINGS OF THE BLACK COLORADAN RACIAL  
24 EQUITY STUDY PURSUANT TO SECTION 2-2-2307 (1)(d).

25 (b) THE RECOMMENDATIONS MUST ADVANCE DEVELOPMENTALLY  
26 APPROPRIATE BUT COMPREHENSIVE INSTRUCTION THAT:

27 (I) INCLUDES A DIVERSITY OF OPINIONS AND NARRATIVES WITHIN



1 THE BLACK EXPERIENCE;

2 (II) FEATURES FACTUAL ACCOUNTS OF THE STRUGGLES AND

3 CONTRIBUTIONS OF BLACK AMERICANS IN ALL FIELDS OF ENDEAVOR;

4 (III) REFLECTS BLACK AGENCY AND RESISTANCE AGAINST

5 OPPRESSION;

6 (IV) FOSTERS CROSS-CULTURAL UNDERSTANDING AND EMPOWERS

7 ALL STUDENTS;

8 (V) FEATURES A DIVERSE RANGE OF BLACK ACHIEVEMENTS IN

9 ARTISTIC, SCIENTIFIC, CIVIC, AND BUSINESS ENDEAVORS; AND

10 (VI) INCLUDES THE STUDY OF EARLY AFRICAN CIVILIZATIONS, THE

11 GLOBAL MIGRATIONS OF AFRICAN PEOPLE THROUGHOUT THE AFRICAN

12 DIASPORA, THE SLAVE TRADE AND ENSLAVEMENT IN AMERICA,

13 ABOLITION, RECONSTRUCTION, THE CIVIL RIGHTS MOVEMENT, AS WELL AS

14 BLACK HISTORY IN COLORADO AND LOCAL BLACK HISTORIES WITHIN THE

15 STATE.

16 (c) IN MAKING RECOMMENDATIONS PURSUANT TO SUBSECTION

17 (6)(a) OF THIS SECTION, THE COMMITTEE SHALL:

18 (I) EVALUATE THE MOST RECENT REVISIONS TO THE STATE'S

19 HISTORY AND CIVICS STANDARDS THAT REFLECT THE RECOMMENDATIONS

20 PROVIDED BY THE HISTORY, CULTURE, SOCIAL CONTRIBUTIONS, AND CIVIL

21 GOVERNMENT IN EDUCATION COMMISSION ESTABLISHED IN SECTION

22 22-1-104.3; AND

23 (II) INCLUDE RECOMMENDATIONS FOR ANY UPDATES NECESSARY

24 TO MAKE THE STATE'S HISTORY AND CIVICS STANDARDS CURRENT,

25 ACCURATE, COMPREHENSIVE, AND ALIGNED WITH THE COMMITTEE'S

26 OTHER RECOMMENDATIONS.

27 (8) (a) THE DEPARTMENT SHALL CREATE AND MAINTAIN A

1 RESOURCE BANK OF EXISTING RESEARCH-BASED SCHOLARLY ARTICLES  
2 AND PROMISING PROGRAM MATERIALS AND CURRICULA PERTAINING TO  
3 BLACK HISTORICAL AND CULTURAL STUDIES. THE MATERIALS AND  
4 CURRICULA MAY BE USED IN ELEMENTARY AND SECONDARY SCHOOLS IN  
5 THE STATE. AT A MINIMUM, THE RESOURCE BANK MUST INCLUDE THE  
6 MATERIALS AND RESOURCES THAT THE COMMITTEE RECOMMENDS  
7 PURSUANT TO SUBSECTION (6)(b) OF THIS SECTION. TO THE EXTENT  
8 POSSIBLE, THE RESOURCE BANK MATERIALS, SCHOLARLY ARTICLES, AND  
9 CURRICULA MUST BE YOUTH-FRIENDLY, CULTURALLY SENSITIVE, AND  
10 AVAILABLE IN BOTH ENGLISH AND SPANISH.

11 (b) ON AND AFTER JULY 1, 2026, THE DEPARTMENT SHALL MAKE  
12 THE MATERIALS IN THE RESOURCE BANK AVAILABLE WITHOUT CHARGE TO  
13 LOCAL EDUCATION PROVIDERS, PROFESSIONAL EDUCATORS, PARENTS OR  
14 GUARDIANS OF YOUTH, AND STUDENTS. A LOCAL EDUCATION PROVIDER IS  
15 NOT REQUIRED TO ADOPT OR IMPLEMENT ANY MATERIAL OR CURRICULA  
16 FROM THE RESOURCE BANK. AT THE REQUEST OF A LOCAL EDUCATION  
17 PROVIDER AND SUBJECT TO AVAILABLE RESOURCES, THE DEPARTMENT  
18 SHALL PROVIDE TECHNICAL ASSISTANCE TO THE LOCAL EDUCATION  
19 PROVIDER IN DESIGNING AGE-APPROPRIATE CURRICULA PERTAINING TO  
20 BLACK HISTORICAL AND CULTURAL STUDIES.

21 (c) LOCAL EDUCATION PROVIDERS ARE ENCOURAGED TO REPORT  
22 TO THE DEPARTMENT ON THE EFFECTIVENESS OF THE RESOURCE BANK  
23 MATERIALS AND CURRICULA AND TO RECOMMEND CHANGES TO IMPROVE  
24 THE MATERIALS AND CURRICULA. THE DEPARTMENT IS ENCOURAGED TO  
25 UPDATE THE RESOURCE BANK MATERIALS AND CURRICULA BASED ON  
26 RECOMMENDATIONS FROM LOCAL EDUCATION PROVIDERS, PROFESSIONAL  
27 EDUCATORS, PARENTS OR GUARDIANS OF YOUTH, AND STUDENTS.

1           (9) THE DEPARTMENT MAY SEEK, ACCEPT, AND EXPEND GIFTS,  
2       GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES FOR THE  
3       PURPOSES OF THIS SECTION.

4           **SECTION 4. Appropriation.** For the 2025-26 state fiscal year,  
5       \$19,225 appropriated to the department of education for use by student  
6       learning. This appropriation is from the general fund and is based on an  
7       assumption that the division will require an additional 0.2 FTE. To  
8       implement this act, the division may use this appropriation for content  
9       specialists.

10          **SECTION 5. Safety clause.** The general assembly finds,  
11       determines, and declares that this act is necessary for the immediate  
12       preservation of the public peace, health, or safety or for appropriations for  
13       the support and maintenance of the departments of the state and state  
14       institutions.
