*The Secretary of the Senate and the Chief Clerk of the House of Representatives are authorized to hire Legislative Aides pursuant to Joint Rule 39 of the House of Representatives and the Senate. If Legislative Aides are authorized by the Executive Committee, acting in accordance with such Joint Rule 39, to start prior to the convening of the next regular session, they may be paid at the rate specified in this resolution from the

1 date they are authorized to start.

2 (2) That the Secretary of the Senate and the Chief Clerk of the House
3 of Representatives remain in such capacity after adjournment of the
4 General Assembly *sine die* until the convening of the Second Regular
5 Session of the Seventy-third General Assembly in January, 2022.

6 (3) That the President of the Senate and the Chair of the House
7 Services Committee, with the authorization of the Speaker of the House
8 of Representatives, are hereby separately authorized to retain and hire
9 replacements for such employees for such period of time in the interim
10 between the First Regular Session of the Seventy-third General Assembly
11 and the Second Regular Session of the Seventy-third General Assembly
12 as they deem necessary for their respective houses; except that the office
13 equipment of the General Assembly and the services of such employees
14 shall be used only in connection with official legislative business.

15 (4) That the President of the Senate and the Chair of the House
16 Services Committee, with the authorization of the Speaker of the House
17 of Representatives, are hereby separately authorized to hire such
18 session-only employees for the next regular session as they deem
19 necessary for their respective houses and who may start their employment
20 on the date authorized.
