Section 23-3.3-103 (1), C.R.S., requires that "student financial assistance under [Article 3.3 of Title 23] increase by at least the same percentage as the aggregate percentage increase of all general fund appropriations to institutions of higher education." Funding for the Colorado State Forest Service tree nursery is appropriated to the Colorado State University System (an institution of higher education). The additional cost of providing aligned financial aid, consistent with the provisions of Section 23-3.3-103 (1), C.R.S., is \$1,249,507 General Fund. Legislative Council Staff concurs with this analysis.

The bill requires but does not contain an appropriation clause for FY 2023-24.

## **Description of Amendments in This Packet**

**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$6,632,007 General Fund to the Department of Higher Education for FY 2023-24. This includes \$5,382,500 General Fund to support the State Forest Service tree nursery. Statutory provisions added in the Education Committee Report make this appropriation available through FY 2024-25. It also includes \$1,249,507 General Fund for Need Based Grants to comply with the requirement of Section 23-3.3-103 (1), C.R.S.

#### L.002 and J.002

Bill Sponsor amendment **L.002** (attached) exempts this program from the requirement of Section 23-3.3-103 (1), C.R.S., that "student financial assistance under [Article 3.3 of Title 23] increase by at least the same percentage as the aggregate percentage increase of all general fund appropriations to institutions of higher education." Amendment **J.002** (attached) adds a provision appropriating \$5,382,500 General Fund to the Department of Higher Education for FY 2023-24. (This excludes the additional funding for financial aid.) Statutory provisions added in the Education Committee Report make this appropriation available through FY 2024-25.

The Committee may adopt J.001 <u>OR</u> the combination of L.002 and J.002 but should not adopt both J.001 and J.002.

#### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2023-24 based on the March 2023 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes two set-asides for legislation outside of the package: (1) \$30.0 million General Fund for bills that create ongoing obligations; and (2) \$469.0 million for bills that create one-time obligations for FY 2023-24 (see table below).

The budget package accounts for the 15.0 percent reserve associated with the above placeholders (a total of \$74.9 million).

This bill creates a one-time obligation and requires a General Fund appropriation of \$6,632,007 (if J.001 is adopted) or \$5,382,500 (if J.002 is adopted) for FY 2023-24, reducing the \$469.0 million set aside by the amount selected.
