Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

- **J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$12,053 General Fund to the Legislative Department for FY 2022-23. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.2 FTE.
- **L.008** Bill Sponsor amendment **L.008** (attached) replaces provisions in the bill that require compensation of legislative members from available appropriations and allow Legislative Council Staff to support the task force within existing appropriations with language that compensation and staff support will be from appropriations.

This does not change the estimated fiscal impact. The Legislative Council Staff Fiscal Note already assumed new appropriations would be needed for legislative member compensation, the task force needs staff support, the appropriate entity to provide that staff support is Legislative Council Staff, and that new appropriations would be needed for Legislative Council Staff. However, the amendment removes potential ambiguity about the sources of funding for compensation and staff support since there are no available or existing appropriations to support these costs.

If L.008 is adopted the Committee should still adopt J.001.

Points to Consider

General Fund Impact

The Joint Budget Committee (JBC) is developing a budget package for FY 2022-23. This bill requires a General Fund appropriation of \$12,053 for FY 2022-23, reducing the General Fund available for other FY 2022-23 appropriations by this amount.
