A BILL FOR AN ACT

CONCERNING THE SURCHARGES FOR VIOLATING MOTOR VEHICLE WEIGHT LIMITS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill repeals the statutory surcharges for violating motor vehicle weight limits and substitutes a uniform surcharge of 16% of the base amount of the penalty for each violation.

1 Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 42-4-1701, amend
(4) (a) (II) (A) and (4) (a) (III) (A) as follows:

42-4-1701. Traffic offenses and infractions classified penalties - penalty and surcharge schedule - repeal. (4) (a) (II) (A) A

person convicted of violating section 42-4-507 or 42-4-508 shall be fined pursuant to this sub-subparagraph (A), whether the defendant acknowledges the defendant's guilt pursuant to the procedure set forth in paragraph (a) of subsection (5) of this section or is found guilty by a court of competent jurisdiction.
