Page 5, strike lines 15 through 27 and substitute:  "13-40-111. Issuance and return of summons. (1) Upon filing the complaint as provided REQUIRED in section 13-40-110, the clerk of the court or the attorney for the plaintiff shall issue a summons. The summons shall MUST command the defendant to appear before the court at a place named in such THE summons and at a time and on a day which shall be not less than seven days nor BUT NOT more than fourteen day from the day of issuing the same to answer the complaint of plaintiff. The summons shall MUST also contain a statement addressed".
