

1                   **SECTION 15. Appropriation to the department of corrections**  
2                   **for the fiscal year beginning July 1, 2023.** In Session Laws of Colorado  
3                   2023, **amend** section 3 of chapter 421, (HB 23-1133), as follows:

4                   Section 3. **Appropriation.** For the 2023-24 state fiscal year,  
5                   ~~\$229,783~~ \$379,458 is appropriated to the department of corrections for  
6                   use by institutions. This appropriation is from the general fund. To  
7                   implement this act, the department may use this appropriation for inmate  
8                   telephone calls related to the superintendents subprogram.

9                   **SECTION 16. Appropriation to the department of education**  
10                  **for the fiscal year beginning July 1, 2023.** In Session Laws of Colorado  
11                  2023, **amend** section 7 (1) introductory portion, (1)(f), and **add** (1)(h) of  
12                  chapter 89, (SB 23-221), as follows:

13                  Section 7. **Appropriation.** (1) For the 2023-24 state fiscal year,  
14                  ~~\$115,339,107~~ \$171,439,107 is appropriated to the department of  
15                  education. ~~This appropriation~~ OF THIS APPROPRIATION, \$156,000,000 is  
16                  from the healthy school meals for all program general fund exempt  
17                  ~~account.~~ ACCOUNT AND \$15,439,107 IS FROM THE GENERAL FUND. To  
18                  implement this act, the department may use this appropriation as follows:

19                  (f) ~~\$115,000,000~~ \$171,000,000 for school meal reimbursements;  
20                  and

21                  (h) \$100,000 FOR CONSULTING SUPPORT, WHICH AMOUNT, IF NOT

1 EXPENDED PRIOR TO THE CLOSE OF THE 2023-24 STATE FISCAL YEAR,  
2 REMAINS AVAILABLE FOR EXPENDITURE UNTIL THE CLOSE OF THE 2024-25  
3 STATE FISCAL YEAR.

4 **SECTION 17. Appropriation to the department of natural**  
5 **resources for the fiscal year beginning July 1, 2023.** In Session Laws  
6 of Colorado 2023, **amend** section 2 of chapter 333, (SB 23-186), as  
7 follows:

8 Section 2. **Appropriation.** (1) For the 2023-24 state fiscal year,  
9 \$558,500 is appropriated to the department of natural resources for use  
10 by the oil and gas conservation commission. This appropriation is from  
11 the oil and gas conservation and environmental response fund created in  
12 section 34-60-122 (5), C.R.S. To implement this act, the commission may  
13 use this appropriation for program costs. ANY MONEY APPROPRIATED IN  
14 THIS SUBSECTION NOT EXPENDED PRIOR TO JULY 1, 2024, IS FURTHER  
15 APPROPRIATED TO THE COMMISSION FOR THE 2024-25 STATE FISCAL YEAR  
16 FOR THE SAME PURPOSE.

17 (2) For the 2023-24 state fiscal year, \$85,361 is appropriated to  
18 the department of public health and environment. This appropriation is  
19 from the general fund and is based on an assumption that the department  
20 will require an additional 0.2 FTE. To implement this act, the department  
21 may use this appropriation for clean water program costs. ANY MONEY

1 APPROPRIATED IN THIS SUBSECTION NOT EXPENDED PRIOR TO JULY 1,  
2 2024, IS FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE 2024-25  
3 STATE FISCAL YEAR FOR THE SAME PURPOSE.

4 **SECTION 18. Appropriation to the department of public**  
5 **safety for the fiscal year beginning July 1, 2023.** In Session Laws of  
6 Colorado 2023, section 10 of chapter 404, (SB 23-280), **add** (2) as  
7 follows:

8 Section 10. **Appropriation.** (2) FOR THE 2023-24 STATE FISCAL  
9 YEAR, \$2,000,000 IS APPROPRIATED TO THE DEPARTMENT OF PUBLIC  
10 SAFETY FOR USE BY THE COLORADO STATE PATROL. THIS APPROPRIATION  
11 IS FROM THE HAZARDOUS MATERIALS SAFETY FUND CREATED IN SECTION  
12 42-20-107, C.R.S. TO IMPLEMENT THIS ACT, THE COLORADO STATE  
13 PATROL MAY USE THE APPROPRIATION FOR THE PURPOSES LAID OUT IN  
14 SECTION 8-20-206.5 (6)(D.5)(II), C.R.S.

15 **SECTION 19. Appropriation to the department of public**  
16 **safety for the fiscal year beginning July 1, 2023.** In Session Laws of  
17 Colorado 2023, **amend** section 2 of chapter 83, (SB 23-242), as follows:

18 Section 2. **Appropriation.** For the 2023-24 state fiscal year,  
19 ~~\$100,000~~ \$500,000 is appropriated to the department of public safety for  
20 use by the division of criminal justice. This appropriation is from the  
21 general fund. To implement this act, the division may use this

1       appropriation for DCJ administrative services. ANY MONEY NOT  
2       EXPENDED PRIOR TO JULY 1, 2024, IS FURTHER APPROPRIATED TO THE  
3       DIVISION THROUGH JUNE 30, 2025, FOR THE SAME PURPOSE.

4               **SECTION 20. Safety clause.** The general assembly finds,  
5       determines, and declares that this act is necessary for the immediate  
6       preservation of the public peace, health, or safety or for appropriations for  
7       the support and maintenance of the departments of the state and state  
8       institutions.
