101	CONCERNING TRANSFERS FROM THE UNCLAIMED PROPERTY TRUST
102	FUND TO THE HOUSING DEVELOPMENT GRANT FUND TO EXPAND
103	THE SUPPLY OF AFFORDABLE HOUSING STATEWIDE.

### **Bill Summary**

Joint Budget Committee. Under current law, commencing with the 2020-21 state fiscal year and for 3 total state fiscal years, assuming certain conditions are satisfied, the state is required to transfer \$30 million from the unclaimed property trust fund to the housing development grant fund to support the provision of affordable housing

HOUSE 2nd Reading Unamended June 1, 2020 statewide. The bill delays the starting date for the first transfer by 2 state fiscal years.

Be it enacted by the General Assembly of the State of Colorado: 1 SECTION 1. In Colorado Revised Statutes, 38-13-801, amend 2 3 (3.5)(a) as follows: Unclaimed property trust fund - creation -4 38-13-801. payments - interest - appropriations - records -5 6 (3.5) (a) Notwithstanding any other provision of this section, if, based 7 upon the estimate described in subsection (3.5)(b)(I) of this section, state 8 revenues for the  $\frac{2020-21}{2022-23}$  state fiscal year through the  $\frac{2022-23}{2022-23}$ 9 2024-25 state fiscal year are less than the transfer cutoff amount, the state 10 treasurer shall transfer from the unclaimed property trust fund to the 11 division of housing to be deposited into the housing development grant 12 fund created in section 24-32-721 (1) no later than June 30 of the year in 13 which the economic and revenue forecast is made the amount of thirty million dollars. 14 15 **SECTION 2. Safety clause.** The general assembly hereby finds, 16 determines, and declares that this act is necessary for the immediate 17 preservation of the public peace, health, or safety.
