### A BILL FOR AN ACT

## 101 CONCERNING A GRANT PROGRAM FOR AREA TECHNICAL COLLEGES.

# **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <a href="http://leg.colorado.gov">http://leg.colorado.gov</a>.)

The bill establishes a grant program to provide money to area technical colleges (ATC) for specified capital construction and equipment purchases. An ATC may submit a request to the Colorado commission on higher education (commission). The commission may include the grant request in its budget request for ATCs in the following state fiscal year. If the ATC receives grant money, the ATC must submit a report back to the commission in any year in which it expends grant money.

1	Be it enacted by the General Assembly of the State of Colorado:
2	<b>SECTION 1. Legislative declaration.</b> (1) The general assembly
3	finds and declares that:
4	(a) Career and technical education ensures that qualified workers
5	are ready to enter high-wage, high-skill, and in-demand career fields that
6	are vital to Colorado's infrastructure and growing economy;
7	(b) Career and technical education plays a key role in reaching the
8	statewide sixty-six percent postsecondary attainment goal by providing
9	career-ready skills to historically underserved and nontraditional students;
10	(c) Career and technical education is critical to mitigating the
11	equity gap by offering affordable and accessible educational opportunities
12	that allow students to graduate debt-free and enter fields with competitive
13	wages and benefits;
14	(d) Career and technical education is required for many of the
15	fastest growing occupations according to the federal bureau of labor
16	statistics, including nursing, welding, massage therapy, dental and
17	medical assisting, and barbering and cosmetology; and
18	(e) Industry demand for skilled workers in today's growing
19	economy continues to outpace the rates of career and technical education
20	certificate completion, particularly in the construction and health care
21	fields.
22	(2) Therefore, it is the intent of the general assembly to establish
23	a grant program for the area technical colleges to provide accessible,
24	high-quality, and current career and technical education programs.
25	SECTION 2. In Colorado Revised Statutes, add 23-71-304 as
26	follows:

15	TECHNICAL COLLEGES FOR IDENTIFIED CAPITAL CONSTRUCTION AND
16	EQUIPMENT PURPOSES IN ADDITION TO THE DIRECT GRANTS RECEIVED
17	PURSUANT TO SECTION 23-18-304 (2)(a). ON OR BEFORE JULY 15, 2019,
18	AND ON OR BEFORE EACH JULY 15 THEREAFTER, AN AREA TECHNICAL
19	COLLEGE MAY SUBMIT A GRANT APPLICATION DEVELOPED PURSUANT TO
20	SUBSECTION (3) OF THIS SECTION TO THE DEPARTMENT. THE DEPARTMENT
21	SHALL REVIEW THE APPLICATION AND RECOMMEND TO THE COMMISSION
22	WHETHER TO INCLUDE MONEY FOR THE GRANT IN ITS BUDGET REQUEST
23	PURSUANT TO SECTION 23-18-304 (2) FOR THE FOLLOWING STATE FISCAL
24	YEAR. THE COMMISSION SHALL DETERMINE WHETHER TO INCLUDE MONEY
25	FOR THE GRANT IN THE BUDGET REQUEST. IF THE DEPARTMENT RECEIVES
26	MONEY FOR THE GRANT, THE DEPARTMENT SHALL TRANSMIT THE FULL

1	(3) THE DEPARTMENT SHALL DEVELOP A FORM FOR THE GRANT
2	APPLICATION THAT MUST INCLUDE:
3	(a) IDENTIFICATION OF HOW THE GRANT MONEY WILL BE SPENT;
4	(b) Specification of how the grant money will benefit
5	STUDENTS AND ANY PROGRAM AT THE SCHOOL; AND
6	(c) ANY MATCHING MONEY TO BE ADDED TO THE GRANT MONEY
7	AND THE SOURCE OF THE MATCHING MONEY.
8	(4) If an area technical college receives grant money
9	PURSUANT TO THIS SECTION, ON OR BEFORE AUGUST 1 OF THE BUDGET
10	YEAR FOLLOWING ANY EXPENDITURE OF MONEY FROM A GRANT, THE AREA
11	TECHNICAL COLLEGE SHALL SUBMIT A REPORT TO THE DEPARTMENT ON A
12	FORM DEVELOPED BY THE DEPARTMENT THAT MUST INCLUDE:
13	(a) THE AMOUNT OF THE GRANT RECEIVED;
14	(b) THE TOTAL AMOUNT OF GRANT EXPENDITURES MADE DURING
15	THE PREVIOUS BUDGET YEAR;
16	(c) AN ITEMIZATION OF THE GRANT EXPENDITURES MADE DURING
17	THE PREVIOUS BUDGET YEAR; AND
18	(d) THE IMPACT OF THE GRANT EXPENDITURES ON STUDENTS.
19	SECTION 3. In Colorado Revised Statutes, 23-18-304, amend
20	(2) as follows:
21	23-18-304. Funding for specialty education programs - area
22	technical colleges - local district colleges. (2) (a) Except as provided in
23	paragraph (b) of this subsection (2) SUBSECTION (2)(b) OF THIS SECTION,
24	for the 2015-16 state fiscal year and each fiscal year thereafter, the direct
25	grants made to eligible area technical colleges pursuant to part 3 of article
26	71 of this title TITLE 23 for a state fiscal year must be equal to the amount
27	of the grants made in the preceding state fiscal year, increased or

1 decreased by a percentage equal to the percentage change in the total state 2 appropriation for the applicable state fiscal year from the total state 3 appropriation for the preceding state fiscal year. 4 (b) The commission may recommend as part of its budget request 5 that: 6 Direct grants to area technical colleges increase by a (I) 7 percentage that is greater than the percentage change in the total state 8 appropriation for the preceding state fiscal year or decrease by a 9 percentage that is less than the percentage change in the total state 10 appropriation for the applicable fiscal year from the total state 11 appropriation for the preceding state fiscal year; AND 12 (II) IN ADDITION TO THE AMOUNT RECEIVED PURSUANT TO 13 SUBSECTION (2)(a) OR (2)(b)(I) OF THIS SECTION, ONE OR MORE AREA 14 TECHNICAL COLLEGES RECEIVE ADDITIONAL MONEY FOR GRANTS 15 PURSUANT TO SECTION 23-71-304. 16 **SECTION 4.
