The bill directs the state treasurer to transfer, on the effective date of the bill, \$5 million from the general fund to the energy outreach

Colorado low-income energy assistance fund (fund). The Colorado energy office administers the fund for use by Energy Outreach Colorado, which organization provides direct utility bill payment assistance to low-income households. Energy Outreach Colorado must expend the money before June 30, 2021.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 **SECTION 1.** In Colorado Revised Statutes, 40-8.7-112, amend 3 (2)(a), (2)(f)(VI), and (2)(f)(VII) as follows:4 40-8.7-112. Department of human services low-income energy 5 assistance fund - creation - energy outreach Colorado low-income 6 energy assistance fund - creation - Colorado energy office low-income 7 energy assistance fund - creation - definitions - repeal. (2) (a) (I) There is hereby created in the state treasury the energy 8 9 outreach Colorado low-income energy assistance fund, administered by 10 the Colorado energy office. The fund consists of all money transferred by the state treasurer as specified in section 39-29-109.3 (2)(f) and any other 11 12 money that the general assembly appropriates or transfers to the fund for 13 the purposes set forth in this subsection (2). All money in the fund is 14 continuously appropriated to the Colorado energy office for distribution 15 to the organization to be used for the purposes set forth in this subsection 16 (2). EXCEPT AS PROVIDED IN SUBSECTION (2)(a)(II) OF THIS SECTION, all 17 money in the fund at the end of each fiscal year remains in the fund and 18 does not revert to the general fund or any other fund. 19 (II) (A) ON THE EFFECTIVE DATE OF THIS SUBSECTION (2)(a)(II), 20 THE STATE TREASURER SHALL TRANSFER FIVE MILLION DOLLARS FROM THE 21 GENERAL FUND TO THE ENERGY OUTREACH COLORADO LOW-INCOME 22 ENERGY ASSISTANCE FUND. THE COLORADO ENERGY OFFICE SHALL 23 DISTRIBUTE THE MONEY TRANSFERRED PURSUANT TO THIS SUBSECTION
