10 11 12 13	WHEREAS, In times of conflict around the globe, it is particularly appropriate to recognize the Coloradans in all branches and components of the Armed Services who serve around the world to protect the security and peace of our nation and other nations; and
14 15 16 17	WHEREAS, In addition to active members of the Armed Services, Colorado is the proud home of more than 390,000 military veterans who have served their country long and well and who bring great honor and distinction to the state; and

22 23 24 25	WHEREAS, We should also never forget the sacrifices made for us by the 94 service members from Colorado declared missing in action or prisoners of war while defending the principles of liberty and justice in conflicts in Korea, Laos, and Vietnam; and
