- 4 TO COMMIT OFFERING OF A FALSE INSTRUMENT FOR RECORDING OR
- 5 FORGERY.".
- 6 Page 2, lines 19 and 20, strike "CREATING A FALSE SLATE OF
- 7 PRESIDENTIAL ELECTORS." and substitute "OFFERING OF A FALSE
- 8 INSTRUMENT FOR RECORDING AS SET FORTH IN SECTION 18-5-114.".
- 9 Page 3, line 19, strike "SERVING IN A FALSE SLATE OF PRESIDENTIAL
- 10 ELECTORS." and substitute "FORGERY AS SET FORTH IN SECTION
- 11 18-5-102.".
- Page 4, line 2, strike "A" and substitute "FOR PURPOSES OF THIS SECTION,
- 13 A".
- 14 Page 4, after line 5 insert:
- 15 "(e) FOR PURPOSES OF THIS SECTION, A PERSON WHO HAS NOT BEEN
- 16 ELECTED AS A PRESIDENTIAL ELECTOR IN A GENERAL ELECTION AND WHO
- 17 INDUCES ANOTHER PERSON WHO HAS NOT BEEN ELECTED AS A
- 18 PRESIDENTIAL ELECTOR IN A GENERAL ELECTION TO KNOWINGLY AND
- 19 FALSELY SWEAR OR ATTEST TO THE OATH REQUIRED BY LAW FOR
- 20 PRESIDENTIAL ELECTORS UNDER SECTION 1-4-304 (1) COMMITS
- 21 SUBORNATION OF PERJURY.".

- 1 Page 4, strike lines 6 through 19 and substitute:
- 2 "(2) (a) Upon conviction for conspiring to offer a false
- 3 INSTRUMENT FOR RECORDING OR FORGERY, AS SET FORTH IN SUBSECTION
- 4 (1)(a) OF THIS SECTION, OFFERING A FALSE INSTRUMENT FOR RECORDING,
- 5 AS SET FORTH IN SUBSECTION (1)(b) OF THIS SECTION, OR FORGERY, AS SET
- 6 FORTH IN SUBSECTION (1)(c) OF THIS SECTION, THE COURT SHALL IMPOSE
- 7 A FINE OF NOT MORE THAN TEN THOUSAND DOLLARS ON THE DEFENDANT.".
- 8 Page 4, line 20, strike "(d)" and substitute "(b)".
- 9 Page 4, line 21, after "SECTION," insert "OR SUBORNATION OF PERJURY AS
- 10 DESCRIBED IN SUBSECTION (1)(e) OF THIS SECTION,".
- Page 4, line 24, strike "CONSTITUTION." and substitute "CONSTITUTION,
- 12 AND IMPOSE A FINE OF NOT MORE THAN TEN THOUSAND DOLLARS ON THE
- 13 DEFENDANT.".
