- (B) THE MOST COMMONLY REQUIRED GUARANTEED-TRANSFER PATHWAYS COURSES IDENTIFIED PURSUANT TO SECTION 23-1-108.5; AND
- (C) The most commonly chosen pathways at institutions of higher education in the state identified by the annual return on investment report produced pursuant to section 23-1-135 (3) or identified by a comparable report or data set. For a pathway identified pursuant to this subsection (6)(g)(II)(C) that is subject to a statewide degree transfer agreement established pursuant to subsection 23-1-108 (7), the best practices guide must include information regarding courses that are required for the pathway.
