1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **repeal** part 3 of
3 article 20 of title 23.

4 **SECTION 2.** In Colorado Revised Statutes, 23-18-308, **amend**
5 (1)(l) and (1)(m); and **repeal** (1)(n) as follows:

6 **23-18-308. Fee-for-service contracts - grants to local district**
7 **colleges - limited purpose - repeal.** (1) Subject to available
8 appropriations, the department shall enter into fee-for-service contracts
9 for the following purposes:

10 (l) The Colorado multidisciplinary health-care provider access
11 training program created in section 23-21-1103; AND

12 (m) The creation of education programs pursuant to ~~section~~
13 ~~8-15.7-201~~; SECTION 8-15.7-201.

14 ~~(n) The recovery-friendly workplace program created in part 3 of~~
15 ~~article 20 of this title 23. This subsection (1)(n) is repealed, effective~~
16 ~~September 1, 2028.~~

17 **SECTION 3. Appropriation - adjustments to 2025 long bill.**

18 (1) To implement this act, appropriations made in the annual general
19 appropriation act for the 2025-26 state fiscal year to the department of
20 higher education are adjusted as follows:

21 (a) The general fund appropriation for the college opportunity
22 fund program to be used for limited purpose fee-for-service contracts
23 with state institutions is decreased by \$412,577; and

24 (b) The reappropriated funds received from the limited purpose
25 fee-for-service contracts with state institutions under subsection (1)(a) of
26 this section for the regents of the university of Colorado is decreased by
27 \$412,577, and the related FTE is decreased by 1.5 FTE.

1 **SECTION 4. Effective date.** This act takes effect July 1, 2025.

2 **SECTION 5. Safety clause.** The general assembly finds,
3 determines, and declares that this act is necessary for the immediate
4 preservation of the public peace, health, or safety or for appropriations for
5 the support and maintenance of the departments of the state and state
6 institutions.
