**Section 1** of the bill appropriates \$73,587,761 total funds for the Legislative Department for FY 2024-25, including:

1. \$71,784,409 General Fund;
2. \$90,000 cash funds; and

3. \$1,713,352 reappropriated funds.

This section reflects a total of 449.2 FTE.

More detailed information about the appropriations for each legislative agency is included in the February 23, 2024 booklet titled, "Colorado Legislative Department: 2024-25 Fiscal Year Budget Request".

**Section 2** of the bill appropriates \$50,000 General Fund to the Youth Advisory Council Cash Fund for FY 2024-25 to support the Youth Advisory Council.

**Section 3** of the bill amends the appropriations in the FY 2023-24 Legislative Appropriation Bill (S.B. 23-197) to make \$29,000 of the existing FY 2023-24 General Fund appropriation to the Legislative Council available through FY 2024-25 to support new legislator orientation and official functions.
