Joint Budget Committee. The bill:

- Removes a \$50 fee for dairy plant employees who sample or test milk, cream, or any other dairy product;
- Increases the licensing fee a dairy plant is required to pay by 30%; and
- Creates a new fee of one cent for every 100 pounds of

milk, to be paid by a dairy plant that receives 20,000 pounds or more of milk each day.

The department of public health and environment is required to cap the amount a dairy plant must pay in total for the licensing fee and volume of production fee at \$150,000.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-5.5-107, amend
3 (2) and (4)(a)(II); and **add** (4)(a)(III) and (4)(a)(IV) as follows:

4 **25-5.5-107. Testing and sampling of dairy products - unlawful**
5 **acts - licensing - dairy protection cash fund - created.** (2) It is
6 unlawful for any person to sample or test milk, cream, or any other dairy
7 product to determine the value of such product when bought and sold or
8 to instruct another person for such purpose without first having a license
9 granted by the department, which license shall be conspicuously
10 displayed in the person's place of business. Licenses shall be granted to
11 those persons who have completed a course in milk and cream testing ~~in~~
12 AT any recognized college or dairy school or to those persons who have
13 passed a satisfactory examination under the direction of the department.
14 Payment of a yearly fee of fifty dollars ~~is required, and the license shall~~
15 ~~be issued for a period of one year from the July 1 next preceding the~~
16 ~~actual date of issue; however,~~ The license shall be subject to cancellation
17 by the department at any time if it finds that the person holding the license
18 is incompetent or guilty of violating this part 1.

19 (4) (a) (II) Except for a transfer or receiving station, which shall
20 be charged the fee set forth in ~~sub-subparagraph (A) of this subparagraph~~
21 ~~(H) SUBSECTION (4)(a)(II)(A) OF THIS SECTION,~~ the fee for a license issued
22 under this subsection (4) shall be determined and paid according to the

8 (III) SUBJECT TO THE LIMITATION IN SUBSECTION (4)(a)(IV) OF
9 THIS SECTION AND IN ADDITION TO THE FEE REQUIRED IN SUBSECTION
10 (4)(a)(II) OF THIS SECTION, A DAIRY PLANT THAT RECEIVES MORE THAN
11 TWENTY THOUSAND POUNDS OF MILK PER DAY SHALL PAY ONE CENT FOR
12 EACH ONE HUNDRED POUNDS OR FRACTION THEREOF OF MILK RECEIVED.

13 (IV) IF THE TOTAL AMOUNT OF FEES REQUIRED IN SUBSECTIONS
14 (4)(a)(II) AND (4)(a)(III) OF THIS SECTION WOULD REQUIRE A DAIRY PLANT
15 TO PAY MORE THAN ONE HUNDRED FIFTY THOUSAND DOLLARS IN A YEAR,
16 THE DEPARTMENT SHALL REDUCE THE VOLUME OF PRODUCTION FEE IN
17 SUBSECTION (4)(a)(III) OF THIS SECTION UNTIL THE TOTAL AMOUNT THE
18 DAIRY PLANT IS REQUIRED TO PAY UNDER SUBSECTIONS (4)(a)(II) AND
19 (4)(a)(III) OF THIS SECTION IS ONE HUNDRED FIFTY THOUSAND DOLLARS.

20 **SECTION 2. Effective date.** This act takes effect July 1, 2023.

21 **SECTION 3. Safety clause.** The general assembly hereby finds,
22 determines, and declares that this act is necessary for the immediate
23 preservation of the public peace, health, or safety.
