A BILL FOR AN ACT CONCERNING AUTHORITY FOR THE EXECUTIVE COMMITTEE OF THE LEGISLATIVE COUNCIL TO ALLOW REMOTE TESTIMONY BEFORE LEGISLATIVE COMMITTEES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

Under current law, the legislative council committee of the general assembly is permitted to establish policies allowing legislative committees to take remote testimony from one or more centralized remote sites around the state. The bill would allow the executive committee of the legislative council to establish policies allowing legislative

committees to take testimony from government officials and employees and the public.

1 Be it enacted by the General Assembly of the State of Colorado: 2 SECTION 1. In Colorado Revised Statutes, 2-3-303, amend 3 (2)(g) as follows: 4 **2-3-303.** Functions - report - definitions. (2) In addition to any 5 other powers and duties set forth in law, the executive committee of the 6 legislative council has the following powers and duties: 7 (g) (I) (A) To consider, recommend, and establish policies 8 allowing legislative committees to take remote testimony from one or 9 more centralized remote sites located around the state GOVERNMENT 10 OFFICIALS AND EMPLOYEES AS WELL AS OTHER MEMBERS OF THE PUBLIC. 11 (B) If remote testimony is approved, at least one remote site 12 established pursuant to sub-subparagraph (A) of this subparagraph (I) 13 must be located in the western slope area of the state. 14 (C) The video teleconferencing technology need not televise, nor 15 otherwise allow testifying members of the public to see, the committee of 16 reference proceedings, so long as the members of the public are able to 17 hear such proceedings and communicate with the committee. 18 (II) In implementing this paragraph (g), the executive committee 19 may enter into agreements with state institutions of higher education to 20 use those institutions as the centralized remote sites and to use the 21 resources, including facilities, equipment, and staff, of those institutions. 22 (III) The executive committee may, in its discretion, implement 23 the use of video teleconferencing in phases. 24 (IV) Nothing in this paragraph (g) SUBSECTION (2)(g) supersedes 25 the power of the house of representatives or the senate to adopt rules or

1	joint rules, or both, for the orderly conduct of their affairs.
2	(V) After the adjournment of the second regular session of the
3	seventieth general assembly, but prior to August 1, 2016, the director of
4	research of the legislative council shall submit to the members of the
5	general assembly a report containing the following information pertaining
6	to remote testimony taken pursuant to this paragraph (g):
7	(A) The total number of persons who testified remotely;
8	(B) The locations of the sites from which such persons testified;
9	(C) The average length of hearings at which remote testimony was
10	accepted;
11	(D) The estimated calculation of travel miles saved by allowing
12	persons to testify remotely;
13	(E) The cost to implement the remote testimony process;
14	(F) The technological or other issues, if any, that arose;
15	(G) Identification of other suitable sites from which remote
16	testimony can be taken, in a manner that ensures that adequate geographic
17	distribution of sites is achieved;
18	(H) Any recommendations that the director believes would
19	improve the taking of remote testimony; and
20	(I) Any other information that the director believes relevant or
21	useful.
22	SECTION 2. Safety clause. The general assembly hereby finds,
23	determines, and declares that this act is necessary for the immediate
24	preservation of the public peace, health, or safety.
