WHEREAS, The military history of African Americans spans from 2 3 the arrival of the first enslaved Africans during the colonial history of the United States to the present day; and 4 WHEREAS, African Americans have participated in every war 5 6 7 fought by or within the United States, including the Revolutionary War, the War of 1812, the Mexican-American War, the Civil War, the Spanish-American War, the Indian Wars, World Wars I and II, the 8 Korean War, the Vietnam War, the Gulf War, and the wars in 9 Afghanistan and Iraq; and WHEREAS, Nearly 198,000 African-American soldiers served 10 during the Civil War, roughly 350,000 African-American soldiers served 11 during World War I, and another 1.25 million African-American soldiers 12 13 served during World War II, with many more African Americans serving 14 in the years since World War II; and
