After consideration on the merits, the Committee recommends the following:

HB16-1098 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, after line 1 insert:
"SECTION 1. In Colorado Revised Statutes, 19-1-303, **amend**
3 (5) as follows:
4 **19-1-303. General provisions - delinquency and dependency**
5 **and neglect cases - exchange of information - civil penalty.** (5) The
6 provisions of this section ~~shall be~~ ARE in addition to and not in lieu of
7 other statutory provisions of law pertaining to the release of information.
8 Access to OR EXCHANGE OF information not otherwise addressed by this
9 section ~~shall be~~ IS governed as otherwise provided by law.".
- 10 Renumber succeeding sections accordingly.
- 11 Page 3, strike lines 10 through 19.
- 12 Renumber succeeding sections accordingly.
- 13 Page 3, line 23, strike "Commencing" and substitute "Commencing
14 NOTWITHSTANDING THE PROVISIONS OF SECTION 19-1-303 (5), C.R.S.,
15 COMMENCING".
- 16 Page 4, line 5, strike "student." and substitute "student INFORMATION,
17 INCLUDING EXPUNGED RECORD INFORMATION, RELEASED BY A DISTRICT
18 ATTORNEY TO THE DIVISION OF CRIMINAL JUSTICE PURSUANT TO THIS
19 SECTION MUST ONLY BE USED FOR RESEARCH PURPOSES RELATED TO

1 SCHOOL DISCIPLINE.".

2 Page 4, after line 9, insert:

3 **"SECTION 4.** In Colorado Revised Statutes, 22-32-146, **amend**

4 (5) (b) as follows:

5 **22-32-146. School use of on-site peace officers as school**
6 **resource officers.** (5) (b) NOTWITHSTANDING THE PROVISIONS OF
7 SECTION 19-1-303 (5), C.R.S., on or before August 1, 2016, and every
8 August 1 thereafter, each law enforcement agency that is acting or has
9 acted in its official capacity on school grounds, in a school vehicle, or at
10 a school activity or sanctioned event shall report to the division of
11 criminal justice, in formats developed by the division in conjunction with
12 local law enforcement agencies, the information required pursuant to
13 paragraph (c) of this subsection (5) that is related to all student tickets,
14 summons, or arrests that occurred for the previous academic year,
15 including incidents that occurred during the previous summer months, at
16 a public elementary school, middle or junior high school, or high school;
17 in a school vehicle; or at a school activity or sanctioned event.".
