Amend page 3, line 1, after "statement -" insert "commercial building conversion tax credit program cash fund -".
Page 9, line 11, after "BE" insert "CREDITED TO THE COMMERCIAI BUILDING CONVERSION TAX CREDIT PROGRAM CASH FUND CREATED IN SUBSECTION (15) OF THIS SECTION AND".
Page 17, after line 11 insert:
"(15) Commercial building conversion tax credit program cash
fund. (a) The commercial building conversion tax credit
PROGRAM CASH FUND IS CREATED IN THE STATE TREASURY. THE FUND
CONSISTS OF GIFTS, GRANTS, DONATIONS, FEE REVENUE CREDITED TO THE
FUND PURSUANT TO SUBSECTION (6) OF THIS SECTION, AND ANY OTHER
MONEY THAT THE GENERAL ASSEMBLY MAY APPROPRIATE, TRANSFER, OF
REQUIRE BY LAW TO BE CREDITED TO THE FUND.
(b) The state treasurer shall credit all interest and
INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
COMMERCIAL BUILDING CONVERSION TAX CREDIT PROGRAM CASH FUND
TO THE FUND.
(c) Money in the fund is continuously appropriated to the
OFFICE FOR THE PURPOSE OF ADMINISTERING THE TAX CREDIT ISSUED
DUDGUANT TO THIS SECTION
PURSUANT TO THIS SECTION.  (d) THE STATE TREASURER SHALL TRANSFER ALL UNEXPENDED
