AMOUNT OF REIMBURSEMENT DESCRIBED IN SUBSECTION (1) OF THIS

SECTION, ON OR BEFORE JANUARY 1, 2019, AND ON OR BEFORE JANUARY

1 EACH YEAR THEREAFTER, EACH COUNTY AND EACH CITY AND COUNTY

- 1 SHALL REPORT TO THE JOINT BUDGET COMMITTEE THE AVERAGE COST OF
- 2 CONFINING AND MAINTAINING PERSONS IN A LOCAL JAIL FOR MORE THAN
- 3 SEVENTY-TWO HOURS AFTER EACH SUCH PERSON HAS BEEN SENTENCED TO
- 4 THE CUSTODY OF THE DEPARTMENT. ON OR BEFORE SEPTEMBER 1, 2018,
- 5 THE JOINT BUDGET COMMITTEE SHALL ESTABLISH GUIDELINES TO ENSURE
