A BILL FOR AN ACT

101 CONCERNING PARKING FOR PEOPLE WITH CERTAIN DISABILITIES, AND, 102 IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates a remuneration-exempt identifying placard that exempts an individual with a disability from paying for parking if the disability limits the individual's:

- ! Fine motor control in both hands;
- ! Ability to reach a height of 42 inches from the ground due to lack of finger, hand, or upper extremity strength or

! Ability to reach or access a parking meter due to the use of a wheelchair or other ambulatory device.

The bill repeals existing authority for a person with a disability to park without paying.

Be it enacted by the General Assembly of the State of Colorado:

2 **SECTION 1.** In Colorado Revised Statutes, 42-3-204, amend 3 (3)(b)(I) and (3)(b)(III); and **add** (1)(i.5), (1)(i.7), (3)(a)(II.5), and 4 (5)(h)(I.5) as follows: 5 42-3-204. Reserved parking for persons with disabilities -6 applicability - definitions - rules. (1) Definitions. As used in this 7 section: 8 (i.5) "REMUNERATION-EXEMPT IDENTIFYING PLACARD" MEANS AN 9 IDENTIFYING PLACARD ISSUED UNDER THIS SECTION THAT EXEMPTS THE 10 HOLDER FROM PAYING REMUNERATION AT PARKING DEVICES. 11 (i.7) "REMUNERATION-EXEMPT QUALIFYING DISABILITY" MEANS 12 A DISABILITY THAT LIMITS AN INDIVIDUAL'S: 13 (I) FINE MOTOR CONTROL IN BOTH HANDS; 14 (II) ABILITY TO REACH A HEIGHT OF FORTY-TWO INCHES FROM THE 15 GROUND DUE TO LACK OF STRENGTH OR MOBILITY IN THE INDIVIDUAL'S 16 FINGER, HAND, OR UPPER EXTREMITY; OR 17 (III) ABILITY TO REACH OR ACCESS A PARKING METER DUE TO THE 18 USE OF A WHEELCHAIR OR OTHER AMBULATORY DEVICE. 19 Types of plates or placards. (a) Authorization. The 20 department may issue the following registration type for issuing disabled 21 plates and placards that notify the public that the vehicle transports a 22 person who may use reserved parking: 23 (II.5)A THREE-YEAR REMUNERATION-EXEMPT IDENTIFYING

24	KNOWLEDGE OF THE PENALTIES FOR OBTAINING A PLACARD WHEN

26	(C) A COLORADO DRIVER'S LICENSE OR IDENTIFICATION
27	DOCUMENT, OR AN IDENTIFICATION DOCUMENT ISSUED BY THE UNITED

3	SECTION 2. In Colorado Revised Statutes, 42-4-1208, amend
4	(3)(e)(I); and add (1)(f.5) and (3)(a.5) as follows:
5	42-4-1208. Reserved parking for persons with disabilities -
6	applicability - rules. (1) Definitions. As used in this section:
7	(f.5) "REMUNERATION-EXEMPT IDENTIFYING PLACARD" HAS THE
8	SAME MEANING AS SET FORTH IN SECTION 42-3-204.
9	(3) Misuse of reserved parking. (a.5) A PERSON SHALL NOT,
10	WHILE PARKED IN A PARKING SPACE THAT REQUIRES REMUNERATION,
11	DISPLAY A REMUNERATION-EXEMPT IDENTIFYING PLACARD THAT IS NOT

19	SECTION 3. In Colorado Revised Statutes, amend 42-4-1212 as

22	(1) Unless the method of remuneration is reasonably accessible to a
23	person with a disability as defined in section 42-3-204, no A person who
24	owns, operates, or manages a parking space that requires remuneration
25	shall NOT tow, boot, or otherwise take adverse action against a person AN
26	INDIVIDUAL or motor vehicle parking in such THE space for failure to pay
27	the remuneration if the motor vehicle bears a REMUNERATION-EXEMPT

15	(3) A law OR PARKING enforcement agency shall withdraw any
16	penalty assessment notice or summons and complaint that is deemed not
17	to be a violation under subsection (2) of this section WITHIN FIVE
18	BUSINESS DAYS AFTER BEING SHOWN PROOF THAT THE INDIVIDUAL CITED
19	HAS A VALID REMUNERATION-EXEMPT IDENTIFYING PLACARD.
20	(4) For the purposes of this section, "reasonably accessible" means
21	meeting the standards of 28 CFR 36 (appendix A) or substantially similar
22	standards.
23	SECTION 4. In Colorado Revised Statutes, 42-4-1701, amend
24	(4)(a)(VIII) introductory portion as follows:
25	42-4-1701. Traffic offenses and infractions classified -
26	penalties - penalty and surcharge schedule - repeal. (4) (a) (VIII) $ A $
27	person who violates section 42-3-204 (7)(f)(II) or section 42-4-1208

4	SECTION 5. Appropriation. For the 2018-19 state fiscal year,

15	approved by the people at the general election to be held in November
16	2018 and, in such case, will take effect on January 1, 2019, or on the date
17	of the official declaration of the vote thereon by the governor, whichever
18	is later.
19	(2) This act applies to conduct occurring on or after the applicable
20	effective date of this act.
