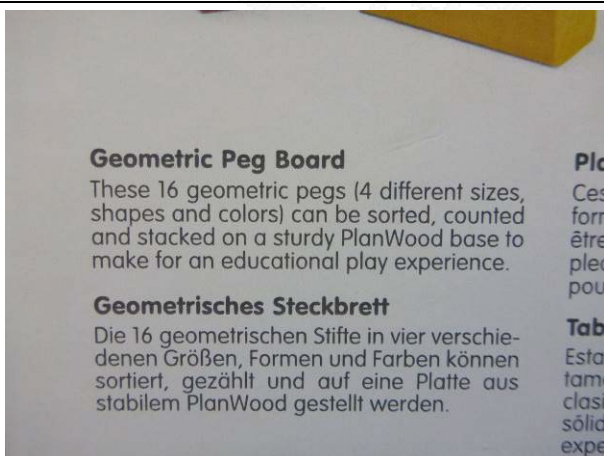
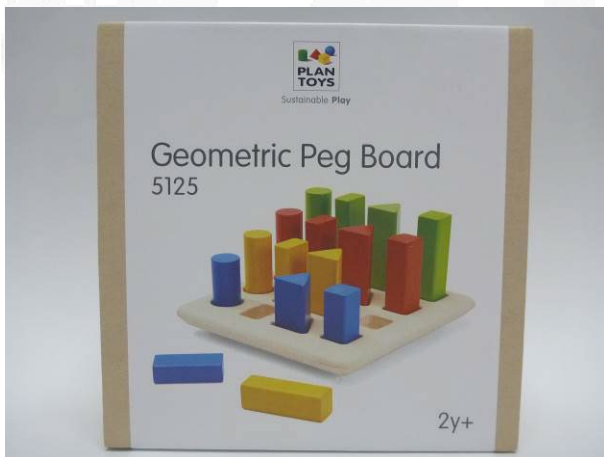

These 16 geometric pegs (4 different sizes, shapes and colors) can be sorted, counted and stacked on a sturdy PlanWood base to make for an educational play experience.

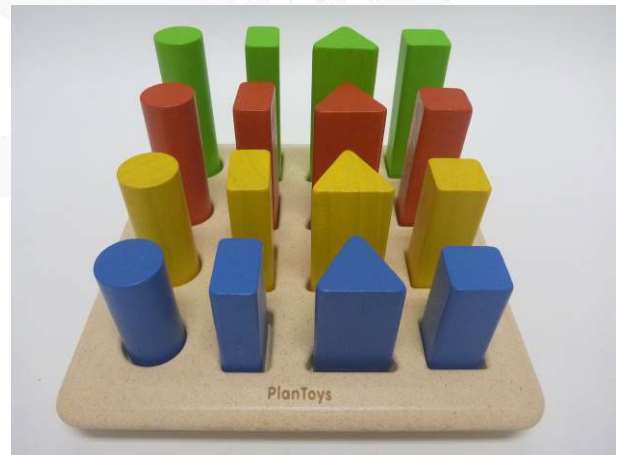
