## **OVERVIEW OF LED Security Light INSTALLATION**

### GENERAL INSTRUCTIONS:

- This fixture operates on line voltage (standard household power) of 120 Volts, 60 Hertz.
- · Can be used in wet locations.
- · Suitable for Type IC or NON-IC installations.
- · Operation temperature ranging between  $-20^{\circ}\text{C}$  to  $+40^{\circ}\text{C}$  ( $-4^{\circ}\text{F}$  to  $+113^{\circ}\text{F}$ ). Lamp life may be affected outside these temperatures.





STEP 1: Ensure all electricity is turned off.






STEP 2: Align the Gasket (D) with the holes in the Mounting Plate (B) and attach the Mounting Plate (B) with Gasket (D) to the junction box (not included) using the two screws (G). Screws should pass through the holes in the Mounting Plate, then the Gasket, then threaded into the junction box.



**STEP 3**: Connect the supply wires to the junction box using the provided wire nuts (black to black, white to white and green/ground to ground).




**STEP4**: Attach the LED Security Light (A) to the Mounting Plate (B) using the Mounting Plate Screw (D).




STEP5: Cover the now secured center screw with the rubber plug.

Insert the Rubber Plug (C) into the Center Screw Hole to conceal the Mounting Plate Screw (D).



**STEP6**: Seal the gap between the LED Security Light and the structure using outdoor sealant. Refer to local building codes to determine the proper sealant as building codes vary by location.
