





STEP 1: Ensure all electricity is turned off.



STEP 2: This item is a 5-CCT selectable light. Choose the desired operating color temperature before installation by moving the dial to the desired color. This item by default is set to 3000K out of the box.


STEP 3:

Remove the lens from the disc. Take care to not touch any of the diodes or components to avoid damage to the light.




STEP 4:

Install supplied Ground wire to recessed can housing using an existing screw, Screw the E26 adapter into recessed can socket, and connect the supply wires to the wires on E26 adapter




STEP 6:

Installing the LED fixture Insert the torsion spring into the slots of the recessed housing. Tuck all wires into the recessed housing and carefully push the trim into the recessed

Finally, twist the lens back onto the disc to complete installation.
