How it Works?

OPTION 1: Sell your own properties

\$599 per annum

Note: Conjunctional Agent agreement required

- » RAAS Property Group Conjunctional Agent must hold a Real Estate Agent's License.
- » A Conjunctional Agent must enter into a RAAS Property Group Conjunctional Agent's Agreement.
- » Conjunctional Agent must take out their own Professional Indemnity Insurance policy to cover their sales activities. While Conjunctional Agents have some coverage under the RAAS Property Group Professional Indemnity policy, it is necessary for them to have their own cover to satisfy the Taxation Office.
- » RAAS will pay the agreed fee as per your Conjunctional Agreement, upon settled sales in the complex.
- » When the Conjunctional Agent is paid by RAAS Property Group, it is done on the production of a Tax Invoice by the Conjunctional Agent. The Tax Invoice must show the commission owing and the GST applicable.

OPTION 2: Sales referral agreement

\$599 per annum

- » A sales referral agent must enter into a RAAS Property Group letter of referral agreement.
- » RAAS is responsible for marketing, open home inspections, contract negotiation and preparation, right through to settlement.
- » An agreed referral fee, determined by yourself and the RAAS Agent, will be paid upon settled sales in the complex within 7 days of cleared funds.
