



## Posting for Part-time, Term-limited Field Technician Position

Thank you for your interest in Jefferson Land Trust and the part-time, term-limited Field Technician position. At Jefferson Land Trust our short- and long-term team members are committed to our mission, *"Helping the community preserve open space, working lands, and habitat forever"* and demonstrate a passion for protecting natural habitat, forests, farmland, and scenic open spaces.

### Position Summary

This Field Technician will support the short- and long-term stewardship responsibilities of Jefferson Land Trust by implementing field-based activities that support the desired future condition of protected properties. The Field Technician will work as part of a small team to accomplish field-based maintenance and restoration projects, including blackberry removal, trash pickup, restoration planting maintenance, and more.

### Schedule and rate

This part-time, term-limited position is for one 8-hour day per week, 9 am – 5 pm, March – December, 2023. The Field Technician must be available consistently on either Monday, Wednesday, or Friday weekly. The hourly rate is \$22/hr.

### Essential Functions

- Perform a variety of stewardship actions including but not limited to invasive weed removal, restoration project maintenance, restoration tree planting, and tool maintenance
- Demonstrate strong work ethic and practice basic safety practices
- Work as part of a team
- Represent Jefferson Land Trust to Preserve visitors and neighbors
- Other duties as assigned.

*We recognize that a good candidate for this position may not precisely meet all the qualifications and core competencies below but may have transferable skills; if you believe you're the right person for this job and can make that case, we encourage you to apply.*

### Qualifications

- Must be at least 18 years of age
- Experience in habitat restoration and maintenance field work
- Commitment to conservation with a passion for protecting natural habitats, farmland, and scenic open spaces



- Demonstrated commitment to diversity, equity, inclusion, and justice principles.

### **Physical Requirements**

- Physically able to conduct demanding field work with hand tools and mechanical tools (training provided) and traverse occasionally rough terrain in a variety of weather conditions
- Ability to lift 20-40 pounds
- Ability to climb over brush, logs, fences, creeks, and other obstacles on protected properties

### **Location**

This position will be based out of our office at 1033 Lawrence St, Port Townsend. There is potential to begin the workday in Chimacum on a case-by-case basis.
