The Property is a historic Greek house built in 1928 in the French Eclectic design that has key architectural features including a stucco and limestone exterior, a stair tower, casement windows, and a hip roof with flared eaves. The Property was remodeled in 2009 and is heated and cooled, sprinkled throughout and features elevator access to all floors, and has three staircases for additional ingress and egress.

This three-story house has 20 individual bedrooms with capacity for 36, with 12 bedrooms and a large restroom on the second floor and 8 bedrooms and a large restroom on the third floor. The basement features a large kitchen and dining/chapter room, laundry, study lounge, and exercise room, while the first floor is configured with two large living rooms, library, study room, recreation room, and restroom. The property will be provided partially furnished and a full FF&E list is available upon request.

The Property is prominently located along Second Street between Armory Avenue and Gregory Drive, just west/southwest of the Illini Union, Main Quad and the greater University of Illinois campus. The property is within easy walking distance to academic buildings, Memorial Stadium, and the Armory, and surrounded by numerous fraternities and sororities



















Study Lounge Living Room Library









Laundry Room Bedroom Corridor Kitchen






