
The layout consists of a bar and dining area, a gaming area (5 machines), 2 restrooms, a full kitchen, a prep room, and a walk-in cooler.

Sportsman's Lounge is on the corner of Mason St and Rutledge St near Downtown Springfield and within the Mid-Illinois Medical District. The location benefits from proximity to the large medical campus that includes two major hospitals (Memorial Medical Center, HSHS St. John's Hospital) and the SIU School of Medicine, many government buildings, and the State Capitol tourism, which brings many regional and national visitors to the area every year.

Springfield is the Capital of Illinois. It is located in Central Illinois and is accessed by both Interstate 55 and Interstate 72.
