2019 Digital Orthophoto Imagery, Tile Format:

Available digital orthophoto imagery is captured from aerial photography (obtained from an aircraft equipped with custom designed cameras). All digital orthophotography is delivered in a georeferenced format, with no compression.

Edge of Pavement & Parking Lots –Currently available are features digitally mapped from 2014& 2015 aerial photography, and updated as needed. Cobb County requested that features mapped to meet ASPRS Class 1, large-scale, map accuracy standards.

Specifications:

- All graded roads, gravel-surfaced or otherwise improved to edge of pavement
- Public vs. private are not be determined. Unimproved roads (logging roads, golf course cart paths, jeep trails) are not represented.
- Centerlines and edge of pavements are not attributed with names.
- The actual edge of pavement (EOP) will be mapped, the road is a continuous feature.
- Paved & concrete parking lots included

Hydrography – Current Available data.

Includes: Rivers, Streams

Specifications:

- All waterways are mapped as streams and show a continuous network.
- All clearly defined channels are mapped even though they have no water showing.

2-foot Contours: Full County dataset update in 2015 from LiDAR technology

Contours are a pattern of lines, with each line drawn through points of equal elevation. These line patterns follow the contour of the landform. Cobb County has requested contour lines that meet ASPRS Class 1, large-scale, map accuracy standards for 2' contour intervals.
