

Description of Route 10 Proposal
Effective July 11, 2017

Proposed Route Modification

Route 10 bus service along Spring Rd as well as Cobb Pkwy (US 41) from Circle 75 Pkwy to Windy Ridge Pkwy is proposed to be re-aligned to Cumberland Blvd, as follows:

- From Marietta Transfer Center (MTC), Route 10 buses will travel south on Cobb Pkwy, turn right on Cumberland Blvd and continue to Cumberland Transfer Center (CTC).
- From CTC, Route 10 buses will travel north on Cumberland Blvd, turn left on Cobb Pkwy and continue to MTC.

Route 10 bus service along Northside Pkwy as well as Cobb Pkwy south of Akers Mill Rd is proposed to be re-aligned to Akers Mill Rd and the I-75 HOV lanes, as follows:

- From CTC, Route 10 buses will travel south on Cumberland Blvd, turn left on Akers Mill Rd and right on I-75 HOV ramp
- From I-75 HOV lane, Route 10 buses will exit at Akers Mill HOV ramp, turn left on Akers Mill Rd and right on Cumberland Blvd, continuing to CTC
- Customers impacted will continue to be served by MARTA's Route 12.

Route 10 bus service to and from MARTA Arts Center Station is proposed to be re-aligned to use existing HOV access points, as follows:

- From southbound I-75, Route 10 buses will exit Northside Dr HOV Ramp, turn right on Northside Dr, left on 17th St, right on Peachtree St, right on 16th St, left on Arts Center Wy, right on 15th St and right into Arts Center Station
- From Arts Center Station, Route 10 buses will exit the north side of the station, turn right on West Peachtree St, left on 17th St, right on Northside Dr and left onto the I-75 HOV ramp

All residents of Cobb County whose interests are affected by the proposed modification are hereby notified and invited to appear at said times and places and present such evidence, comment, or objections as their interests require.

A court reporter will be available during this time to allow the public an opportunity to make comments about the proposed modification. These comments will be included in the transcript of the Public Hearing.
