Relocating a House into Cobb County

When relocating a house into Cobb County, the following criteria must be met before it can be considered before the Board of Commissioners.

- 1. An engineer or a registered land surveyor must provide a plat of the property
 - Plat must be submitted to the Zoning and Plan Review sections of Development and Inspections to be approved.
- 2. Submit the following to the Code Enforcement Office:
 - a. A letter stating all improvements that will be made to bring the structure up to Cobb County Building Codes (Garage, fireplace, carport, etc.)
 - A letter of sewer availability or a septic tank permit from the Cobb and Douglas Public Health Department
 - c. A letter stating where the funds for these improvements will come from (Borrow from bank, personal savings account, etc.)
 - d. A letter stating plans for occupancy (Rent, sale, owner occupied, etc.)
 - e. Plat of the property, signed off by the Zoning and Plan Review sections
- 3. These items must be brought to the Code Enforcement Office at 1150 Powder Springs Street, Suite 400, in Marietta, GA on or before the deadline given. <u>Each deadline will be different depending on the date of the Zoning hearing</u>

Once the complete application is submitted, the Code Enforcement Office will provide an Other Business sign to be posted thirty (30) days prior to your scheduled Board of Commissioners Zoning Hearing. This sign posting is mandatory.
