ORDER

The offenses designated herein are payable under the Traffic Violations Bureau in the amount equal to the base payable amount plus all applicable surcharges required by statute without the requirement of a court appearance, with the exception that any case involving an accident shall not be assigned to the Traffic Violations Bureau.

Uniform traffic citations filed in as of July 1, 2020 will be subject to this order. This order supersedes any previous orders designating particular offenses payable as Traffic Violations Bureau offenses.
