A Public Review Meeting will be held at 10:00 a.m. on Thursday, March 14, 2019 at the Cobb County Board of Commissioners room located at 100 Cherokee Street, Marietta, Georgia to receive comments on Cobb County's PY2018 Consolidated Annual Performance & Evaluation Report [CAPER] for the time period of January 1, 2018 to December 31, 2018. The U.S. Department of Housing and Urban Development [HUD] requires Cobb County to submit an annual report describing its performance using federal, state, local, and private resources to meet priorities and objectives set forth in the County's PY2016 - 2020 Consolidated Plan. This report provides a review of activities carried out under the Community Development Block Grant [CDBG], Emergency Solutions Grant (ESG), and HOME Investment Partnerships (HOME) Program to address the needs of the low and moderate income citizens, the homeless, the elderly and the mentally and/or physically disabled persons in Cobb County.
