Chairman Daniell called the meeting to order at 4:01 p.m.

Public Comment: Becky Arrington spoke regarding 2018 election.

Mr. Aiken moved to approve the January 8, 2018 Regular Meeting minutes. Mr. Pettit SECONDED.

Mr. Pettit moved to authorize the following precinct changes:

- A boundary change to existing precinct Dobbins 01, Windy Hill Community Center, 1885 Roswell St. SE, Smyrna GA 30080 by receiving a portion of the existing precinct Fair Oaks 05, Fair Oaks United Methodist Church, 1480 Joyner Ave., Marietta, GA 30060. None
- A boundary change to existing precinct Fair Oaks 01, currently voting at Open Bible Tabernacle, 545 Lorene Dr., Marietta, GA 30060, by giving a portion to precinct Fair Oaks 02, Milford Baptist Church, 1030 Milford Church Rd. SW, Marietta, GA 30060, and a portion to precinct Oregon 03, Fair Oaks Recreation Center, 1465 Brandon Dr., Marietta, GA 30008. The existing precinct Fair Oaks 01 will be dissolved.
- A boundary change to existing precinct Fair Oaks 02, currently voting at Milford Baptist Church, 1030 Milford Church Rd. SW, Marietta, GA 30060, by receiving a portion from precinct, Fair Oaks 01, Open Bible Tabernacle, 545 Lorene Dr., Marietta, GA 30060 and by giving a portion to precinct Fair Oaks 04, LaBelle Elementary School, 230 Cresson Dr., Marietta, GA 30060, and a portion to precinct Oregon 03, Fair Oaks Recreation Center, 1465 Brandon Dr., Marietta, GA 30008.
- A boundary change to existing precinct Fair Oaks 04, LaBelle Elementary School, 230 Cresson Dr, Marietta, GA 30060 by receiving a portion of the existing precinct Fair Oaks 02, Milford Baptist Church, 1030 Milford Church Rd. SW., Marietta, GA 30060.
- A boundary change to existing precinct Fair Oaks 05, currently voting at Fair Oaks United Methodist Church, 1480 Joyner Ave., Marietta, GA 30060, by giving a portion to precinct Dobbins 01, Windy Hill Community Center, 1885 Roswell St. SE., Smyrna, GA 30080, and a

portion to precinct Oregon 03, Fair Oaks Recreation Center, 1465 Brandon Dr., Marietta, GA 30008. The existing precinct Fair Oaks 05 will be dissolved.

- A boundary change to existing precinct Oregon 03, currently voting at Fair Oaks Recreation Center, 1465 Brandon Dr., Marietta, GA 30008, by receiving a portion from precinct, Fair Oaks 01, Open Bible Tabernacle, 545 Lorene Dr., Marietta, GA 30060 and a portion from precinct Fair Oaks 02, Milford Baptist Church, 1030 Milford Church Rd. SW., Marietta, GA 30060, and a portion from precinct Fair Oaks 05, Fair Oaks United Methodist Church, 1480 Joyner Ave., Marietta, GA 30060.
- A boundary change to combine precinct Lewis 01, Lewis Elementary School, 4179 Jim Owens Rd., Kennesaw, GA 30152, with precinct McClure 01, McClure Middle School, 3660 Old Stilesboro Rd., Kennesaw, GA 30152. The combined precinct will be known as McClure 01. Precinct Lewis 01 will be dissolved.

Mr. Aiken SECONDED. APPROVED 5-0.

Ms. Eveler requested the Board's approval to conduct a nonpartisan election for the Georgia Soil & Water Conservation Commission on November 6, 2018 and direct the Chairman to sign a memorandum of agreement. Ms. Brooks moved to approve conducting the election and the signing of the documents. Mr. Pettit SECONDED. APPROVED 5-0.

Ms. Eveler requested the Board authorize a municipal special election to be conducted in conjunction with the May 22, 2018 General Primary in order to fill the Post 2 vacancy on the Kennesaw City Council and further to authorize the Chairman to sign the necessary documents. Mr. Pettit moved to approve conducting the election and the signing of the documents. Mr. Daniell SECONDED. APPROVED 5-0.

Ms. Eveler requested the Board authorize a municipal special election to be conducted in conjunction with the May 22, 2018 General Primary in order to fill an expected Ward 6 vacancy on the Smyrna City Council, provided that the City takes action such that the Call can be published by the required February 21, 2018 deadline, and further to authorize the Chairman to sign the necessary documents. Mr. Daniell moved to approve conducting the election and the signing of the documents. Mr. Aiken SECONDED. APPROVED 5-0.

Chairman Daniell set the next regular meeting for March 12, 2018 at 4:00 p.m.

Mr. Aiken moved to adjourn the meeting at 4:26 p.m. Mr. Wilson SECONDED. APPROVED 5-0.
