Chairman Gartland called the meeting to order at 4:01 p.m.

Mr. Drexinger moved to approve the regular September 9, 2013 Board Meeting Minutes. Mr. Aiken SECONDED. APPROVED 4-0.

Pursuant to O.C.G.A. Section 21-2-228, a hearing was held by the Board of Elections and Registration to determine the eligibility to remain on the Electors List of 82 persons, a list of which is available to review in the Elections Office upon request. Prior legal notice for said hearing had been given to the named individuals and those individuals had failed to appear for the hearing. Therefore, based on the available evidence, the Board ruled that these voters are no longer qualified to be registered in Cobb County. Ms. Beth Kish has approval to override this ruling if more information is received from the voter. Mr. Aiken moved to remove the names of those voters (82) whose qualifications to be registered have been challenged. Mr. Drexinger SECONDED. APPROVED 4-0.

Ms. Joyette Holmes arrived at 4:06 p.m.

Mr. Daniell moved to authorize a boundary change to combine existing precinct Smyrna 2B, First Baptist Church of Smyrna, 1275 Church Street, Smyrna GA 30080 with Smyrna 2A, Smyrna Fire Station #3, 2825 Park Rd, Smyrna GA 30080. The combined precinct will be known as Smyrna 2A. The existing precinct Smyrna 2B, First Baptist Church of Smyrna, will be dissolved. Mr. Drexinger SECONDED. APPROVED 5-0

Mr. Daniell moved to authorize a boundary change to existing precinct Sprayberry 01, Piedmont Road Church of Christ, 1630 Piedmont Road, Marietta GA 30066 by giving a portion of voters to precinct Gritters 01, Crossview Baptist Church, 1100 Piedmont Road NE, Marietta GA 30066 and a portion of voters to precinct Elizabeth 03, Marietta Alliance Church, 1787 E. Piedmont Road, Marietta GA 30062. The existing precinct Sprayberry 01, Piedmont Road Church of Christ, will be dissolved. Mr. Drexinger SECONDED. APPROVED 5-0.

Mr. Daniell moved to authorize a boundary change to existing precinct Tritt 01, Northeast Cobb YMCA, 3010 Johnson Ferry Road, Marietta GA 30062 by giving a portion of voters to precinct Hightower 01, Hightower Trail Middle School, 3905 Post Oak Tritt Rd, Marietta GA 30062 and a portion of voters to precinct Roswell 01, East Cobb Church of Christ, 5240 Roswell Road, Marietta GA 30062. The existing precinct Tritt 01, Northeast Cobb YMCA, will be dissolved. Mr. Drexinger SECONDED. APPROVED 5-0.

Ms. Eveler asked the Board to approve the appointment of Felisa Evans as the Superintendent's representative on the Vote Review Panel for the November 5, 2013 General/Special Election. Mr. Drexinger moved to approve the appointment presented by Ms. Eveler. Ms. Holmes SECONDED. APPROVED 5-0.

Mr. Daniell moved to approve the 2014 Board Meeting Calendar. Mr. Drexinger SECONDED. APPROVED 5-0.

Chairman Gartland set the next regular meeting for November 11, 2013, at 8:00 a.m. The Board will also convene at 7:00 p.m. on November 5, 2013 at West Park Government Center for the purpose of observing election night tabulation.

Mr. Aiken moved to adjourn the meeting at 4:36 p.m. Mr. Daniell SECONDED. APPROVED 5-0.
