

**NOTICE OF INTENT TO CHANGE PRECINCT BOUNDARIES**

NOTICE IS HEREBY GIVEN to the voters of precinct **SMYRNA 3A**, located at **SMYRNA COMMUNITY CENTER**, that the Board of Elections and Registration recommends the **SMYRNA 3A** precinct be divided to form **SMYRNA 3B** precinct.

The polling place location for **SMYRNA 3B** will be located at **SHILOH SEVENTH DAY ADVENTIST CHURCH, 810 CHURCH STREET SE, SMYRNA, GA 30080**. The remaining portion of **SMYRNA 3A** will continue to vote at **SMYRNA COMMUNITY CENTER, 200 VILLAGE GREEN CIRCLE SE, SMYRNA, GA 30080**.

The Board recommends this change pursuant to O.C.G.A. Section 21-2-262, and for the convenience of the voters.

The Board of Elections and Registration will hold a public hearing on **January 13, 2020 at 4:00 pm** in the **CONFERENCE ROOM AT WEST PARK GOVERNMENT CENTER, 736 Whitlock Avenue, Marietta, Georgia**, to hear any objections to this change. Any objections must be filed in writing before the time of the hearing or presented orally during the hearing. If no objection is made, the Board will adopt this change at that time.

If no objection is made, the Cobb County Board of Commissioners will consider this change for adoption at their regularly scheduled meeting on January 14, 2020.




