## Fiscal Year 2020/2021 Community Service Block Grant (CSBG) CARES AMENDED BUDGET LINES

On August 11, 2020, the BOC approved CSBG CARES recommended funding allocations. While the CSBG CARES funding in the Fiscal Year, 2020 recipients will continue to expend funds during the 2021 Fiscal Year.
