V. COBB-MARIETTA COLISEUM & EXHIBIT HALL AUTHORITY APPOINTMENT-

• Keylan Mitchell opened discussion regarding the formal process document. After conversations with Jill Flamm and Bill Carver, edits were suggested. These included allowing the Cobb-Marietta Galleria & Exhibit Hall Authority to submit a nomination for consideration.

- Jill Flamm made a motion to accept the revised guidelines dated 8/11/20 and to add in item (3) and remove the "s" from nominations in the first sentence of item (3). Keylan Mitchell seconded the motion. Bill Carver added that in item (1) "prevue" needed to be corrected to "purview".
- Vote: All in favor, none opposed.
- Keylan Mitchell opened discussion on a timeline moving forward. September meeting gives about two weeks, October meeting pushes process into November/December when a quorum may be more challenging. Keylan will send an email with specific dates/deadlines.

VI. SPLOST REPORTING

Barbara Savage provided a brief summary of SPLOST projects.

- 2011 projects close to the end
 - Fellton perimeter fence to be installed. Tree clearing began today. Fellton's will stipulates that we must install memorial plaque on property, currently working on. Home featured on cover of August 1967 *Southern Living* Magazine
- 2016 projects winding down
 - Discovery Blvd retaining walls installed, restroom building plans submitted, expect completion around end of October
 - East Cobb stage roof replacement to be complete next week
 - 20 pavilion and concession stand roofs replaced with standing seam
 - Fullers LED lighting installed and ready for synthetic turf, estimate completion April 2021
 - Harrison added 44 parking spaces including 2 ADA spaces
 - Hyde Farm concrete floors in barn sealed, waiting on Cobb EMC to connect power then complete. Bollards to be installed to keep vehicles from driving through property
 - Larry Bell sanitary sewer line project bid, working on insurance
 - Miller mobile stage in production
 - Nesbitt Union Chapel 1 acre site deeded to trust in 1886, developing scope for future plans depends on funding, no timetable
 - Old Clarkdale in permitting, hopefully complete next summer
 - Security cameras nine facilities in planning
 - Stout in design for 3 areas of master plan, working with stormwater & DOT
 - The Art Place roof about half complete, completion early September

- Adult softball started yesterday, 90 teams registered
- Kickball starting
- Cornhole league registration open
- Natural resources looking to start community gardens in various parks
- Tennis Lost Mountain wheelchair tournament August 28-30

- Playground updates hoping to have East Cobb open in the next 2-3 weeks
- Pitner Road Dog Park hopefully complete end of next week
- Mableton Town Square hopefully begin around 8/24
- Looking at larger facilities and alternative projects since they are currently closed to the public
- Hyde all artifacts previously stored by National Parks Service have been moved to our space
- COVID cases in PARKS several cases among staff, some hospitalized

Jimmy Gisi –
