The Cobb County CDBG Program Office is accepting grant applications for **Federal Fiscal Year (FFY) 2022 Community Services Block Grant (CSBG) CARES Supplemental Program**.

On August 4, 2021, Cobb County was awarded CSBG CARES Act Supplemental funds from the Georgia Department of Human Services to address the unmet needs from the impact of the COVID-19 disaster.

The funding level for Cobb County for the FFY 2022 CSBG CARES program beginning October 1, 2021 is \$99,219.00. The application cycle will commence on **Wednesday, August 18, 2021** and end on **Tuesday, September 7, 2021**.
